[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Monday May 21, 2018 the above named defendant did commit the criminal offense of making threats of violence pursuant to Florida State Statue 790.163.

The defendant, who is a student at Crestview High School, informed another student identified as ██████████ that he was going to shoot the school on Friday. According to ██████████ that is the only statement the defendant made to him.

A sworn written statement was obtained from a student identified as ██████████. According to ██████████ sworn statement, she overheard the defendant and witnessed ██████████ in a conversation at lunch in which the defendant said he was going to shoot the school up on Friday May 25, 2018. According to ██████████ the defendant was asked why he would shoot the school up, at which time he responded "why not." ██████████ stated after the defendant made the statements he pulled out a "bullet" and put it on the table. ██████████ reports the bullet was gold in color and medium size.

Contact was made with the defendant by school administrators who searched his person. A live round, "9mm ammunition" was discovered in the defendant's left front pocket. The defendant denied making any statements concerning harming anyone or shooting the school. After the defendant had been provided his Miranda warnings, he did not wish to speak with me about the incident. The defendant later requested contact with me after he had spoken to his mother. The defendant was again advised of his Miranda warnings at which time he agreed to speak with me.

Post Miranda, the defendant, admitted to me that he had made statements to his friend ██████████ about shooting the school up. According to the defendant he did not mean the statement and he could not provide me with a reason as to why he had made the statements. According to the defendant he had been under a lot of stress, and does not have any firearms. The
