[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On May 23, 2018 Nicholas Robert Sachse did violate F.S.S. 784.021.1a Aggravated Assault with a Deadly Weapon

On the above mentioned date, Sachse was walking the second floor of the Home 2 Suites in Destin, FL screaming "Open the fucking door" at room 218. Sachse then pointed a dark colored semi-automatic handgun at the peephole of the door. The tenant staying in room 218, Jared Talbert, was looking thru the peephole at the time Sachse pointed the handgun at it. Sachse's action caused Talbert to fear for his safety and the safety of his family with him.

Sachse then retreated to room 217, where he is staying and which is directly across the hall from 218.

All attempts to make contact with Sachse in room 217 have been met with negative results as he is refusing to come to the door and keeps cussing at law enforcement thru the door.

Based on the above information I have reason to believe, and do believe, Nicholas Sachse is in violation of F.S.S. 784.021.1a Aggravated Assault with a Deadly Weapon
