[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Investigator Douglas G. Schwall, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO) with over 20 years of total civilian law enforcement experience in the State of Florida. Your Affiant is currently assigned to the OCSO Criminal Investigations Division as an Investigator. Your Affiant being duly sworn states as follows:

On 5/28/2018 at approximately 1930 hours, the OCSO was dispatched to 5872 Hillcrest Rd, Crestview, FL in reference to a missing adult. Upon their arrival, they learned that the victim, Nancy Kirk Williams, was missing from her residence at 4189 Painter Branch Road, Crestview. Conducting a welfare check at Nancy's residence, they discovered the following:

(a) Her 2008 light blue 4D Ford bearing FL Tag#0872QY was not at the residence.

(b) Inside the secured garage, the body of Nancy laying inside a bathroom. She was lying face up, her face was covered with a beach towel, her tank top was pushed up which exposed her upper torso, she had dirt and debris in her hair, arms, feet, legs, and other areas of the body; not consistent with the findings inside the bathroom.

Contact was made with the Medical Examiner's (ME) Office who found approximately 9 deformities; 8 on the left side of her face/head and upper region and 1 on the right side; near the chin. She also had what appeared to be several gun shot

wounds in her upper torso leading your Affiant to believe that Nancy was a victim of a homicide.

During the investigation, a person of interest was identified as Jeremiah Payton Murphy. Murphy used to date the granddaughter of Nancy and had frequented the house on numerous occasions. A witness was found in a co-worker of Murphy's (Burger King - Crestview) in which they place Murphy operating Nancy's motor vehicle. Also found was Nancy's Ford; located in the parking lot of the Pic-N-Save (Crestview). There was damage sustained to the driver's side of the vehicle and the driver's side mirror was missing. An interview was conducted with Kate Stalnaker who said she was the girlfriend of Murphy. According to Stalnaker, she places Murphy operating the Ford belonging to Nancy along with a pick-up truck which was also registered to Nancy.

Contact was made with Murphy and he was brought to the OCSO-Brackin Office Substation in Crestview for an interview. Present with Murphy for the interview was his mother and father. Prior to any questions being asked, Murphy was advised of his Miranda Rights; doing so from a pre-printed text. After Murphy and his parents indicated they understood the rights, no request was made to have an attorney present nor was a request made to not answers present. In his interview, Murphy confessed to the following:

(a) He told an unidentified co-defendant about Nancy's residence and the fact there may be items of value inside the home which make it worthwhile to commit a Burglary of a Dwelling and she lived alone.

(b) Murphy said he and the unidentified co-defendant went to the residence on 05/26/18 with the intent to commit a Burglary of a Dwelling, also referred to as, "Hit a lick".

(c) Murphy added that upon the arrival at the residence, contact was made with Nancy outside at which time a firearm was discharged several times by the co-defendant; striking Nancy and killing her.

(d) Post-mortem, Murphy said he went into the residence along with the unidentified co-defendant and removed property, to-wit: United States currency and a cellular telephone.

(e) Post-mortem, Murphy and the unidentified co-defendant grabbed Nancy by the feet/legs and then moved her to the garage area which is where she was discovered.

It is believed that during the commission of the Burglary of a Dwelling, the actions of Murphy caused the death of Nancy.

Based on the above stated facts and investigation, I find probable cause to believe that JEREMIAH PAYTON MURPHY violated F.S.S. 782.04.1A2 – Murder while engaged in certain felony offenses (Felony Murder). This offense occurred in Okaloosa County, where I am a sworn deputy.
