[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 2, 2018, the Defendant, Christopher Phillip Wohrman, was found in possession of a methamphetamine and drug paraphernalia.

On the aforementioned date, I conducted a traffic stop on a 2010 Nissan bearing Florida Tag # 437OVJ for a traffic violation on Mattie Kelly Road in Destin, Florida. The defendant was a passenger located in the drivers rear.

Two individuals located in the back seat were detained in the course of the traffic stop. One had an active Okaloosa County warrant and the other was the defendant. Upon discovering the identity of the defendant, he was released from custody.

The defendant advised he had a backpack in the vehicle and wanted to retrieve it. I asked the defendant for consent to search the backpack, and he agreed. During my search, a black metal grinder containing marijuana was located in one of the zipped pockets. The marijuana was tested and tested presumptive positive. Post Miranda, the defendant admitted the grinder was his.

A search of the vehicle was later conducted. In the area where the defendant was seated a red straw containing a crystal like substance was located. Also in the defendants seat was more of this substance.

Both of these clear substances were tested, and tested presumptive positive for methamphetamine.

Based on my investigation, which consisted of an interview with the defendant, gathering of physical evidence and my personal observation, I have reason to believe and do believe that the defendant, Christopher Phillip Wohrman, violated the provisions of F.S.S. 893.13 (6) (a) Possession of Controlled Substance and F.S.S. 893.147(1) possession of drug paraphernalia. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 2, 2018, the Defendant, Andrew Doyle Keyes, was found in possession of a methamphetamine and drug paraphernalia.

On the aforementioned date, I conducted a traffic stop on a 2010 Nissan bearing Florida Tag # 437 OVJ for a traffic violation on Mattie Kelly Road in Destin, Florida. The defendant was the co-registered owner of the vehicle, and the front seat passenger.

Two individuals located in the back seat were detained in the course of the traffic stop. One had an active Okaloosa County warrant and the other was being detained to verify their identity. The individual with the warrant had

items located in the back seat, a backpack and a clear bag containing coloring pens.

As the bags were being handed to me by the driver, I observed a clear glass pipe and a dark colored glass pipe laying on the floor board of the back seat. The remaining occupants of the vehicle were removed and a vehicle search was conducted based upon drug paraphernalia observed in plain sight.

Deputy Ray Hamilton and Matthew Macbeth were on scene assisting with the traffic stop.

In the glove box of the vehicle was a skull marijuana metal grinder. Post Miranda, the defendant informed me the grinder was his. Deputy Macbeth went to place the defendant in his patrol vehicle. D/S Macbeth asked the defendant if he had any drugs on him. The defendant advised he had a loaded needle in his cargo shorts. This needle was retrieved from the front right cargo pocket. A second unused needle was found in the left cargo pocket. A clear plastic baggie containing a crystal like substance was found in his shirt pocket.

This substance was field tested and tested presumptive positive for methamphetamine.

The defendant stated to D/S Macbeth he had forgotten the drug was in his pocket, and advised he would have used it had he known it was there. Later the defendant informed me the substance was ICE, also known as the purest form of methamphetamine.

Based on my investigation, which consisted of an interview with the defendant, gathering of physical evidence and my personal observation, I have reason to believe and do believe that the defendant, Andrew Doyle Keyes, violated the provisions of F.S.S. 893.13 (6) (a) Possession of Controlled Substance and F.S.S. 893.147(1) possession of drug paraphernalia. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
