[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 2, 2018 the defendant, Robert Tommy Cooper was charged with cocaine possession with intent to sell and trafficking.

On the aforementioned date, I responded to 215 Harbor Blvd. Destin Florida Room 127 (Village Inn of Destin) in reference to a security check.

I made contact with the Cooper who was residing in the stated room. Cooper was advised the reason for our presence was due to complaints from other guests of a large amount of suspicious foot traffic. Cooper consented to a search of the room, to which I discovered a clear bag containing multiple separate bags of what looked to be narcotics stashed in a bucket by the sink. Upon further investigation I discovered three separate small zip lock bags containing white rock like substances, and a sandwich bag containing a large amount of white pills with the imprint 54/425.

Cooper was detained and search incident to arrest revealed a separate sandwich bag containing multiple triangular shaped pills with the imprint p/d. The bag was observed falling out of the center of Cooper's shorts. I also discovered

\$264.00 cash located in the pocket of the shorts.

Post Miranda, Cooper advised the substance that fell out of his shorts was his however what was discovered in the room was not.

132.5 individual/19 grams of white triangle pills with the imprint p/d were identified as 8mg hydromorphone hydrochloride a schedule II narcotic. 25 individual/19 grams of white round pills were identified as 8mg hydromorphone hydrochloride a schedule II narcotic. Utilization of Drugs.com was conducted for identification of the pills. The 10 grams of white rock like substance was field tested and tested presumptive positive for cocaine. All narcotics were weighed, packaged, labeled and placed into evidence for processing.

Prior to leaving the scene Cooper advised there was approximately \$8000.00 located in the room, underneath a television stand. Upon inspection I discovered a sock containing \$7685.00, when questioned on how the money came into his belonging, Cooper advised he went gambling at a casino but could not recall the exact location or name of the casino.

Based on my investigation, which consisted of interviews with the defendant, gathering of physical evidence and my personal observation, I have reason to believe and do believe the defendant Robert Tommy Cooper, violated provisions of F.S.S. 893.135.1c1 Trafficing and 893.13.1(a)1 Possession of Cocaine with intent to sell. This incident occurred in Okaloosa County, Florida, where I am a Sworn Law Enforcement Officer.
