[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 06/04/2018, the Okaloosa County Sheriff's Office was contacted by the Hancock Whitney Bank security monitoring center to notify the agency of suspicious activity at the Hancock Whitney Bank located at 14075 Emerald Coast Parkway, Destin. The security monitoring center stated they had been able to observe an unidentified suspect, driving a white pickup truck, pull up to the drive up ATM and cover the camera with what appeared to be some type of "rebel flag".

According to the security monitoring center, their data showed sequential ATM withdrawals from separate bank accounts to have begun immediately following the covering of the camera and "maxing out" each of the cards being used.

As D/S J. Hamilton arrived on scene at the Hancock Whitney Bank, he observed a white pickup truck pulling away from the scene. An investigative stop was conducted and the driver, Gagik KESAIAN, was detained. At the time KESAIAN was detained, he was found to be grasping a crumpled Confederate Flag window decal, as had been described by the security monitoring center, in his hand. A consent search of the vehicle was conducted by deputies on scene and a soft zipper case containing \$1,600 U.S. Currency, and 6 Hancock Whitney Bank ATM receipts showing sequential withdrawals from 06/04/2018, at 04:38, 04:40, 04:42, 04:43, 04:44, 04:47. The total amount shown withdrawn from the receipts, \$1,600, coincided with the cash found.

Also located in the vehicle was two small card sleeve type envelopes containing a total of 14 blank, counterfeited, credit/debit cards. In a post-Miranda video recorded interview of KESAIAN, he admitted to covering the ATM camera at the bank in order to conceal his identity and utilizing ATM/bank cards in order to withdraw monies from accounts not belonging to him. KESAIAN claimed to have found the blank bank cards and believed it to be a way to obtain "quick and easy money".

Based on the above probable cause the affiant has reason to believe and does believe that the defendant, Gagik KESAIAN has committed the offenses of Grand Theft, Fraudulent Use of a Credit Card, Trafficking in Counterfeit Credit Cards, Criminal Use of Personal Identification Information, and Scheme to Defraud a Financial Institution. These offenses are in violation of Florida State Statutes 812.014(2c1); 817.61(1); 817.611(2a); and 655.0322(6) respectively, and was committed in Okaloosa County, FL.
