

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On July 12, 2018 members of the Okaloosa County Sheriff's Office Street Crimes Unit and Fort Walton Beach Police Department Street Crimes Unit were conducting patrols in the area of Fort Walton Beach, Florida.

Members of Fort Walton Beach Police Department (FWBPD) attempted a traffic stop on a silver in color Honda Minivan bearing Florida tag EZNG64 for traffic violations. I was responding to assist with the traffic stop when I learned from FWBPD the vehicle was failing to stop and they were in an active pursuit. I joined the pursuit in the area of Edge St. and Laurel Dr. The vehicle turned onto Laurel Dr. which is a dead end street. The vehicle made a u-turn and intentionally drove back toward my marked patrol unit instead of the open lane of travel provided to the vehicle. The vehicle continued driving directly at my marked patrol unit which had its emergency lights and siren activated. Fearing a head-on collision was about to occur, I had to abruptly stop my patrol vehicle. The vehicle continued fleeing at a high rate of speed from marked patrol units for several miles with total disregard for public safety. The vehicle committed numerous traffic violations including but not limited to doubling the speed limit and running stop signs in neighborhood subdivisions.

The vehicle stopped after leaving the roadway on a dead end street, the driver exited the vehicle and continued fleeing on foot. After a short foot pursuit the driver was taken into custody and identified as, Jason Thomas HILDEBRANT.

Post Miranda Warning, HILDEBRANT stated he had ingested an unknown amount of what he believed to be methamphetamine. I believe HILDEBRANT was aware the methamphetamine could be used against him in the investigation and therefore, he destroyed it with the purpose to impair its availability in the investigation. HILDEBRANT also stated he was sorry for driving head-on at my patrol vehicle.

During the investigation it was learned HILDEBRANT'S driver's license was revoked on 4/17/2014. A check of DAVID revealed HILDEBRANT had three previous driving while license suspended or revoked (DWLSR) charges with two guilty convictions on 10/10/12 and 3/10/14. DAVID also shows HILDEBRANT listed as a Habitual Traffic Offender on 4/17/14 for a period of 60 months.

Based on the aforementioned facts, I have reason to believe and do believe the Defendant, Jason Thomas HILDEBRANT violated FSS. 893.13(6a) - Possession of Controlled Substance to wit; Methamphetamine, FSS. 784.07(2c) - Aggravated Assault on Law Enforcement Officer, FSS. 918.13 - Destruction of Evidence, FSS. 316.1935(3a) - Aggravated Fleeing and Eluding, FSS. 322.34(5) - DWLSR Habitual Traffic Offender, FSS. 843.02 - Resisting an Officer without Violence.

These offenses occurred in Okaloosa County where I am a Sworn Law Enforcement Officer.
