[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 07/01/2018, I was dispatched to 2000 Principle LN (Belvedere Commons), Fort Walton Beach, Florida, in reference to a Suspicious Person. Dispatch stated a black male, wearing black clothing was looking into cars in the parking lot.

Upon my arrival, I made contact with the victim, at the rear of the building. The victim informed me, his Glock 26 handgun was taken from his vehicle. The victim further realized his Samsung smart phone, Samsung tablet, a pack of Marlboro Special Blend 100's, and SOG serrated blade pocket knife were also taken. The total value of the theft was \$1,835.49.

While the victim completed appropriate paperwork, I spoke with a witness on scene. The witness stated she observed a black male with facial hair, wearing a black t shirt and black shorts, sneaking around cars in the parking lot. The witness called out to the male, asking if he needed help. The male communicated with the witness, before hastily leaving the property, traveling north in the wood line parallel to La Brook CT, Fort Walton Beach, Florida.

D/S Verrey and D/S Herrmann located a black male, matching the above description, behind 925 Mar Walt Drive, Fort Walton Beach, Florida. The male was detained and a show up, with the witness, was conducted. The witness positively identified the male, as the same person she observed in the parking lot. In a post Miranda interview, the defendant, admitted to being in the parking lot of Belvedere Commons. An article search of the nearby wood line, revealed a black t shirt. Inside the shirt a plastic bag was located. The plastic bag contained a Glock 26 handgun, a Samsung smart phone, and a Samsung tablet. A search of the defendant's person, revealed a SOG serrated blade pocket knife and a pack of Marlboro Special Blend 100's, were found in his front left pocket. D/S Verrey and D/S Herrmann spoke with the defendant approximately 2 hours prior. The black t shirt, containing the firearm, was worn by the defendant during this encounter.

The defendant was identified as, STEPHEN JAMES WHITNER. On 07/01/2018, WHITNER did enter the victim's vehicle without permission and while inside did become armed with a handgun, to which he removed from the vehicle without the owner's permission.

During further search of the defendant, a used hypodermic needle was located. The defendant admitted to using Heroin and did not claim to have any medical conditions.

These events did occur within Okaloosa County, FL where I am a sworn Law Enforcement Officer.

I hereby swear (or affirm) that the facts established on this affidavit are true and correct to the best of my knowledge and belief.
