[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On December 29, 2017, an individual using the email account [REDACTED]@yahoo.com contacted an undercover officer posing as a juvenile female. The conversation moved from email to text message. The individual who was later identified as Dallas Corbitt, texted the undercover officer from the cellular number 850-[REDACTED]. During the text conversations Corbitt solicited what he believed to be a thirteen (13) year old juvenile female for sex. Also during the text conversation Dallas sent pictures of his face.

A public records check shows Dallas Corbitt, age 43, lives a 333 Ohio Ave Valparaiso Florida, a public records check of the phone number 850- shows the cellular service is through Verizon and the phone bill returns to 333 Ohio Ave Valparaiso Florida.

On July 15, 2018, I went to Fudpucker's, 20001 Emerald Coast Pkwy, Destin, FL 32541, to inquire if Dallas Corbitt was still employed at the business. When I spoke to a manager I was informed Corbitt still worked at the business and was currently working. I requested to speak with Corbitt.

During a consensual interview Corbitt admitted to the following:

Corbitt admitted his current email address was @yahoo.com, which is the email used to contact the undercover officer.

Corbitt admitted his phone number 850- and that he had that number for over a year. This is the same number used to contact the undercover officer.

Corbitt also admitted that his residence has been and still is 333 Ohio Ave. Valparaiso, Florida.

I asked Corbitt if he had been working at Fudpucker's since January or if he had other employment. Corbitt admitted he did work security for events at Hurricane Lanes and Club LA. This matches up with the conversations Corbitt had with the undercover officer where he stated he worked security for Club LA.

I asked Corbitt if he remembered chatting with a female underage during the time frame of the conversations and he stated he did not remember. I then showed him a picture of the female to see if he remembered and Corbitt also stated he did not remember.

While interviewing Corbitt I realized in the pictures he sent to the undercover officer that his beard was longer than what I was observing. I asked Corbitt if his beard was longer during the January time frame. Corbitt stated his beard was longer during that time frame.

Based on the aforementioned information I have reason to believe and do believe Dallas Corbitt violated Florida State Statutes 847.0135 solicitation of a minor child and 934.215 use of a two way communication device to commit a felony. This incident occurred in Okaloosa County Florida where your Affiant is a sworn law enforcement officer.
