[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 07/05/18 at approximately 0155 hours, the defendant, Tyrone Dewayne Morris Sr., was in possession of a firearm after being convicted of a felony, discharged a firearm in public, and intentionally caused great bodily harm, permanent disability, or permanent disfigurement with a deadly weapon, to wit: firearm, at 892 W. James Lee Blvd, Crestview, Okaloosa County, FL.

On 07/05/18 at approximately 0155 hours, the defendant and the victim became involved in several altercations. The defendant pointed a firearm, believed to be a .40 caliber semi-automatic pistol, at the victim, pulled the trigger, and shot

the victim in the right leg in the area of the knee. The projectile went through and through.

The victim described the suspect as being a black male, in his 30's, approximately 5'8 and 190 pounds, possibly bald headed, and dark skinned. The victim also mentioned the male suspect had gold teeth on his upper teeth. According to the victim, he had prior dealings with the defendant a week prior. A photographic array was provided to the victim and he positively identified the defendant as the shooter.

This incident was captured on video surveillance footage, which substantiates the victim and witnesses statement.

There was one (1) .40 caliber shell casing at the crime scene believe to be from the defendant firearm. There was also six (6) .45 caliber shell casings at the crime scene which are believed to be fired after the victim was shot by another unknown subject.

A criminal history search on the defendant yielded 5 prior felony convictions.

Multiple attempts have been made to locate the defendant which have met with negative results.

Based upon the above information, I have reason to believe and do believe the defendant, Tyrone Dewayne Morris Sr., did violate F.S.S. 784.045(1a2) Aggravated Battery with a Deadly Weapon, F.S.S. 790.23(1a) Possession of a Firearm by a Convicted Felon, and F.S.S. 790.159(1) Discharging Firearm in Public Property. This offense occurred in Okaloosa County, FL where I am a sworn law enforcement officer.
