[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On July 22, 2018, the Defendant Alejandro Flores violated F.S.S 784.045(1a2) by cutting the victim with a knife. The victim Brent Griffin, sustained a laceration across his chest that needed 60 staples to close, a laceration on the left side of his neck up to his ear, slicing his earlobe, a laceration on his upper left arm approximately 6 inches and a laceration on the inside of his left wrist, approximately 1 inch long.

The victim stated his estranged wife, April Griffin came to his residence, located at 5346 Kentucky Street, Crestview, Florida for a prearranged child exchange. Upon arrival, April was accompanied by the Defendant Flores. The victim walked up to April's vehicle and a physical altercation ensued between Defendant Flores and the victim. During the altercation, the defendant pulled out a knife and cut the victim multiple times. The victim stated April grabbed his right arm while Defendant Flores was cutting him with the knife.

This altercation was witnessed by Ryan McGovern and Kristen Elder. Both provided sworn statements corroborating the victim's statement. April Griffin was injured during the altercation and sustained a laceration across her forehead, a laceration on her right

arm and left wrist, each requiring stitches. April stated the victim attacked her and Defendant Flores with a knife.

Defendant Flores post Miranda denied having a knife and stated he was face down on the ground the entire time. Defendant Flores had no knife wounds or defensive wounds.

McGovern had a video system that captured the incident and corroborates the victim and witnesses account of this incident.

Based on the above stated facts I have reason to believe and do believe the Defendant Alejandro Flores violated F.S.S 784.045(1a2), Aggravated Battery with a deadly weapon. This offense occurred in Okaloosa County where I am a sworn Investigator with the office of the Sheriff.
