[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 07/24/2018, a Civil Process Server (CPS) responded to [REDACTED] Crestview. Upon arrival, he discovered the only occupant at the residence was a 6-year-old child, [REDACTED] (6yoa)/VICTIM. The CPS contacted me for further assistance. My investigation revealed the following.

The CPS spoke with the victim, at approximately 0926 hours, for several minutes and the victim indicated there were no adults home. He was unable to observe or speak with anyone else at the residence.

At approximately 0945 hours, deputies made contact at the residence. The victim was the only person present at the time. He told deputies [REDACTED] Roseann Rediker/SUSPECT, left for work leaving him home alone. A DCF Investigator arrived on scene and conducted an interview with the victim. The victim stated he would utilize the oven as one means to cook food for lunch. The victim was asked about safety plans. He said if there was a fire he would get his dog out first then open the garage door then go to a neighbor to call 911. He said if his puppy got loose he would chase him down the street. The victim did not have any means of communication within the residence. The victim said his mother would leave before he woke up and would not return until near dark. The victim had access to the entire house including

the kitchen appliances (oven, microwave) and knives. He also admitted he would open the door for strangers. The victim stated he was sad he did not have anyone to play with and did not know how to play. He explained he would watch movies on his laptop all day.

The suspect arrived on scene and stated the following. She stated the victim never used the oven by himself nor would he open the door for strangers. She also indicated he was familiar with all of the safety plans. She admitted she left home alone when she left for work at the Department of Juvenile Justice. Her roommate also worked near the same schedule with her at the same location. The suspect said had been staying home alone since school ended in May 2018. Some days, a friend would come over to stay with the victim but for only a few hours. The suspect did not feel there was an issue with leaving at home alone several days a week all day. She also indicated he did not have a means to contact her or emergency services.

Based upon the aforementioned facts and information, I have reason to believe and do believe Roseann Rediker did violate the following:

F.S.S. 827.03 (2d) - CHILD NEGLECT WITHOUT GREAT BODILY HARM (the victim was left alone with no supervision, means of communication, and had to care for himself)

This offense occurred in Okaloosa County, Florida, where I am a sworn Deputy Sheriff.
