[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

The defendant, Charles R. Robinson, committed the offense of Possession of Heroin, and resisting without violence.

On 7/5/18 at approximately 1844 hours, I was dispatched to Walmart, 748 N. Beal pkwy Fort Walton Beach, FL. for a citizen that believed the individual wanted for a burglary was in the store. Upon arrival, the individual in question matched the individual in the photos posted on the website. A citizen contact was made and the suspect was identified as CHARLES R. ROBINSON. Robinson paid for his items and exited the store. D/S Swain asked ROBINSON if he may pat him down due to being very finicky in his movements. ROBINSON agreed to let D/S Swain pat him down. During the pat down, ROBINSON reached into his pocket and attempted to discard two plastic jeweler baggies containing a brown substance. D/S Swain attempted to detain ROBINSON, he attempted to run and pulled away. ROBINSON was assisted to the ground and taken into custody. A field test was conducted on the substance ROBINSON attempted to

discard. The substance gave a presumptive positive for heroin. During search incident to arrest, a dollar bill containing a brown substance was located in ROBINSON'S wallet. A field test was conducted and also gave a presumptive positive for heroin.

Based on my investigation, I have reason to believe and do believe the defendant, Charles R. Robinson, violated F.S.S. 893.13 (6)(a) possession of controlled substance to wit heroin, F.S.S. 843.02 resisting without violence, and F.S.S. 893.147.1 possession of drug paraphernalia. These offenses occurred in Okaloosa County where I am a full time, bonded, sworn law enforcement officer.
