

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

The defendant Jeffrey Todd Bowes did commit burglary to a business, larceny > 10,000 and damage criminal mischief, by breaking and entering into a business, utilizing a pry tool and taking over \$12,000 in merchandise. These are in violations of F.s.s. 810.02(4a), 812.014(2c3) and 806.13(1b2) respectively.

On June 9, 2018 at approximately 5:00 a.m. Okaloosa County deputies responded to alarm to business at 1450 Miracle Strip Parkway Okaloosa County, described as the Islander Surf and Sport business. On arrival a burglary was discovered

and affidavit of complaint was received for stolen merchandise as well as damage to the business property. Mainly stolen were sunglasses from the main display case.

Video surveillance in the store showed what appeared to be a white male, ethnicity based on skin color of his legs, with a black ski mask, long sleeve shirt, white shorts, black gloves, black shoes and a black bag. During the break in 82 various models of Oakley and Smith Optics sunglasses were taken according to their inventory sheets, which totals \$12,623.

Subsequent investigation identified surveillance footage from the area surrounding the business and neighboring businesses. During review and investigation of the video surveillance, a female in the video was identified as Jennifer Pentecost accompanied by the defendant in the area the previous night June 8, 2018 at approximately 11:30 p.m. During the surveillance video, the defendant can be seen looking into the business accompanied by Pentecost. The defendant is observed wearing white shorts long sleeve shirt rolled at the sleeves and barefoot. They depart in a dark in color 4-door vehicle resembling a BMW. Interviews with Pentecost later identified the defendant as the person present on the night of June 8, 2018.

Further review of video surveillance from the early morning hours of June 9, 2018, at the adjacent business and the area of the boardwalk show the defendant dressed in the same shorts and shirt matching the exact description driving the same vehicle arriving at approximately 4:30 a.m. The defendant parks his vehicle exits and walks along the adjacent perimeter fence until he finds a gate. The defendant enters the curtilage of the boardwalk and is on video approaching the business carrying a white sack. The defendant is tracked on video until he reaches the second floor where he is observed walking in an out of camera view up until the burglary and during the burglary. The defendant is then seen carrying a large black bag over his shoulder all the way back to where the defendant parked his vehicle and departs.

During the follow up investigations, your affiant was in the process of attempting to locate Jennifer Pentecost. While canvassing known associates of Pentecost your affiant came across the defendant's BMW. During registration checks your affiant recognized the strong resemblance of the defendant. Furthermore your affiant identified the defendant had outstanding warrants. During execution and arrest of the defendant in his residence your affiant observed and seized clothing matching that worn by the defendant not only in the above offense, but also in burglary to business offense being investigated in neighboring counties. During the search warrant follow up interviews with the defendant's aunt and homeowner she also identified the defendant in surveillance footage still shots of the night of the burglary.

Based on the information above I have reason to believe and do believe the defendant committed the offenses stated above. These offenses occurred within Okaloosa County where your affiant is a sworn law enforcement officer.


