[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Between the years of 1993 to 1996, at the age of 35 years old, the Defendant Bobby Jelks Wilson Jr., violated F.S.S 794.011.8c by engaging in a sexual relationship with [REDACTED]

The Victim stated verbally and in a written statement that the sexual abuse began when she was 10 years old and ended when she was 13 years old. The abuse began with the Defendant Wilson performing oral sex on her. The sexual abuse increased in frequency and severity [REDACTED]. The Defendant then began to penetrate her orally, vaginally, and anally with his fingers and penis. This occurred virtually every day during those three years, and generally occurring in his bedroom. She explained that he would normally ejaculate inside her, he told her she could not get pregnant because he was "Sterilized." The defendant would then wipe up the semen from her body with a rag that he kept in his nightstand. The defendant told her if she told anyone what was happening he would send her to live with [REDACTED] this frightened her because [REDACTED] was physically and emotionally abusive. This abuse stopped when the Defendant began a relationship with his second wife.

The victim did disclose the sexual abuse to an out cry witness and to a counselor, both have provided written statements.

The defendant was contacted and declined to provide a statement and invoked his right to counsel.

Based on the above stated facts I have reason to believe and do believe the defendant Bobby Jelks Wilson Jr., violated Florida State Statutes 794.011.8c, Sexual Battery by Custodian with Victim under the age of 12 years old. This offense occurred in Okaloosa County where I am a sworn Investigator with the Office of the Sheriff."
