[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

In the county of Okaloosa, on 08-31-2018, at approximately 0103 hours in the 900 block of Hwy 98 (parking lot of Little Caesar's) in Destin, the defendant, Andrew William Thomas, did commit the offenses of Robbery, Grand Theft, Criminal Mischief, Battery, and Reckless Driving. The defendant had pre-arranged a meeting with the victim, Jordan Weis, who had driven from Pensacola to sell the defendant a \$2500 dollar laptop computer for \$1400 in cash. The defendant, while seated in his car, had the victim place the computer into a backpack inside his running car. The defendant then handed the victim a white in color envelope with "\$1400" written on the outside.

The victim opened the envelope to discover there was no cash, but rather it was filled with pieces of blank paper (Grand Theft). The defendant began to leave by backing up on the lot, then the victim reached through the driver's window in an attempt to retrieve his property. The defendant attempted to deprive said property from the victim's possession by fleeing the scene while the victim was hanging out the window (Robbery). The defendant began battering the victim as he drove forward slamming into concrete curbs, driving over concrete dividers, crashing through bushes and more concrete curbs, as well as, hitting a metal pole causing it to break in a reckless manner with no regard for life or property. The two then exited the car and continued to batter each other fighting over said property as they walked towards Hwy 98. Both the victim and defendant had noticeable swelling to their faces from multiple strikes, as well as, hand, arm, and leg injuries. The property damaged in the lot was valued at approximately \$450 dollars not to include the estimated \$8000 in damage to the car, owned by the defendant's parents.

I do believe that the defendant is in violation of F.S.S. 812.13.1 Robbery, 812.014.2.c.1. Grand Theft, 806.13.1.b.2. Criminal Mischief, 784.03.1.a.2. Battery, and 316.192.1.a. Reckless Driving. This offense did occur in Okaloosa County where I'm a sworn law enforcement officer.
