

SO Dispatch advised the shoplifting suspects were described as a black male with a green shirt and a black female with a short hairstyle. SO Dispatch advised the unknown suspects left the scene in a red Toyota vehicle, bearing Alabama tag 2CB9781. SO Dispatch also advised the vehicle had a red broken left tail light traveling in the general direction of Bonefish Grill. I observed the suspect vehicle in the area of 34683 Emerald Coast Parkway, Destin, FL., and initiated a traffic stop on the vehicle. The occupants of the vehicle matched the general description of the suspects.

Post Miranda, the DEFENDANT, Tyra C. Booker stated she did not steal any of items from any business.

Post Miranda, the driver of the vehicle, Dedric Clinton, confessed to stealing other items from Foot Locker, 4233 Legendary Drive, Destin, FL. Clinton stated the DEFENDANT, stole items from Victoria Secret, 4225 Legendary Drive, Destin, FL as well as other establishments. Clinton stated the DEFENDANT advised him after she stole the items from the establishments, she placed the items in the trunk of the vehicle. Clinton provided law enforcement with an sworn written statement.

Foot Locker employee, [REDACTED] responded to the scene and stated she observed the DEFENDANT on surveillance "stuff" three Jordan shirts in his Express shopping bag. Turner stated the DEFENDANT passed all points of sale and exited the business without paying for the items.
