[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On September 18, 2018, at approximately 0751 hours the defendant, James Chanley Poland, was arrested for Resisting without violence, Possession of marijuana, and Possession of drug paraphernalia.

A call for service was received for an intoxicated driver who had just parked at McDonald's, located at 440 Mary Esther Blvd, Mary Esther, FL. The witness ([REDACTED]), who provided a written sworn statement identified

herself to Lt Kirkpatrick and pointed at the vehicle, a white Buick sedan bearing FL tag IUUP61, which was parked at the business. The witness described the driver who was later found at the counter inside. The witness provided the defendant's driving habit and further stated when he exited the vehicle he was having difficulty standing and walking.

Lt Kirkpatrick made contact with the defendant, who immediately began to walk away upon sight of law enforcement out the other exit away from the motor vehicle. The defendant was asked if he had driven the vehicle and stated he had not and his eyes were darting about as if he were looking for a direction to flee. The defendant was extremely nervous. The defendant was asked his name and would only provide a first name and was asked if he had warrants. The defendant then started to dart and was pinned and told to stop and was being restrained when he was able to get free and run out of the store. The defendant fled from the scene while refusing numerous commands to stop.

The defendant was apprehended a short time later at Longhorn Steak house, located at 544 Mary Esther Cutoff, Mary Esther, FL. Post arrest the defendant made several spontaneous statements acknowledging that he had warrants which is why he ran from the scene. The defendant made another spontaneous statement admitting to smoking marijuana on a regular basis and occasionally smoking crack cocaine; however, he wouldn't acknowledge whether or not he had recently used anything illegal narcotics.

The defendant was identified to have four active warrants for his arrest.

In accordance with agency policy, the vehicle was inventoried which revealed the following articles which were located inside of it. All of these items are also indicative of narcotics use and commonly used with marijuana.

Approximately 3 grams of marijuana
1 marijuana grinder
1 pipe with residue
1 digital scale

The marijuana was field tested which revealed a presumptive positive test result for THC.

The defendant denied ownership of the aforementioned items and stated he was unaware of the items being in the vehicle.

Based off interviews of the suspect, witnesses, and physical evidence. I believe James Poland is in violation of F.S.S 893.13(6b) Possession of marijuana less than 20 grams, F.S.S 893.147(1) Possession of drug paraphernalia, and F.S.S 843.02 resisting Officer without violence.
