[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On September 19, 2018 at approximately 0243 hours, members of the Okaloosa County Sheriff's Office responded to the Sunoco Food Mart, located at 1921 Highway 90, Milligan, Florida, in reference to a business alarm.

Upon deputies arriving, it was discovered that the suspect, later identified as the DEFENDANT, Eddie MCLEESE, had

forced entry into the store by throwing a landscaping stone through a glass door. Upon making entry, the DEFENDANT removed two packs of Native brand cigarettes and a lighter from behind the counter, prior to fleeing the area on foot. Through video surveillance footage, the DEFENDANT was observed to be wearing a blue shirt with stripes, jean shorts, and black shoes.

The damage to the door was valued at approximately \$700.00. The cigarettes and lighter were valued at approximately \$10.00.

On September 19, 2018, the DEFENDANT was located in the area of the Yellow River Bridge on Highway 90, Milligan, Florida. At the time of the contact, the DEFENDANT was wearing the same clothing as depicted in the video surveillance footage. While speaking to the DEFENDANT, your AFFIANT observed an unopened pack of Native brand cigarettes sitting on the railing next to the DEFENDANT. Additionally, your AFFIANT observed the outline of two additional cigarette packages in the DEFENDANT's pockets.

Post Miranda, the DEFENDANT requested the presence of an attorney. The DEFENDANT was advised that he was being placed under arrest for burglary and he was shown a digital image of him inside of the store during the burglary. When your AFFIANT informed the DEFENDANT that he was under arrest for the burglary, the DEFENDANT spontaneously indicated that he would not have done it if the jail had not stolen his cigarettes. The DEFENDANT then indicated that we should "call it even".

Search incident to arrest, one unopened package and one opened packaged of Native brand cigarettes were located in the DEFENDANT's pockets.

There is probable cause to believe, and your AFFIANT does believe, Eddie MCLEESE knowingly violated Florida State Statutes 810.02.4a; Burglary, 806.13.1b2; Criminal Mischief (\$200-\$1000), and 812.014.3a; Petit Theft. This incident did occur within Okaloosa County, Florida, where your AFFIANT is a sworn Law Enforcement Officer.
