On the aforementioned date, at 1934 hours, I was traveling the area of Rocky Bayou Drive, Niceville, Florida, when I observed a female, later identified as Laura Haley sitting on the shoulder of the roadway.

In Laura's interview and sworn Statement, she stated the following: On today's date at 1900 hours, Laura and the Defendant departed a residence in Niceville, Florida. While traveling on the roadway, the Defendant displayed a pink semi-automatic pistol and positioned the barrel of the firearm to Laura's head. The Defendant instructed Laura to continue driving. Laura, in fear for her own personal safety, jumped from the vehicle while traveling at a slow speed. While Laura attempted to seek assistance from other motorists, the Defendant moved from the passenger seat to the driver seat and departed the scene.

The vehicle, described as a black 2007 Nissan Titan pickup, bearing Florida tag 606QCE, is owned by James Morelli. James stated the Defendant deprived him (James) of the vehicle and the Defendant never had permission to drive the vehicle. James completed an Affidavit of Complaint.

A criminal history of the Defendant was conducted and it was determined the Defendant is a convicted felon.

On September 20, 2018, at approximately 2137 hrs, the Defendant was located by Geneva Police Department traveling in the stolen Nissan Titan. Geneva Police Department detained the Defendant, and located a Walther P22 firearm with a pink slide in the Defendant's possession.

Based on my investigation, I have reason to believe the Defendant, Heath Matthew Waldo, committed the offenses of Aggravated Assault with a Deadly Weapon (DOMV), a violation of F.S.S. 784.021.1a1, Grand Theft of Motor Vehicle, a violation of F.S.S. 812.014.2c6, Robbery Carjacking with Firearm, a violation of F.S.S. 812.133.2a, and Possession of a Weapon by Convicted Felon, aviolation of F.S.S. 790.23.1a.
