#### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Sometime between November 2017 and August 30, 2018, the Defendant, Aaron Barnes, did violate Florida State Statue 812.014(2a) Larceny Grand First Degree over \$100,000 by knowingly and unlawfully going into the safe located at 6358 Lake Ella Road, Crestview, Florida and stole \$400,000 dollars worth of silver one dollar coins owned by his father/victim Frank Barnes. The defendant did so with intent to permanently deprive the victim of his right to the property for his own personal use.

The victim provided a sworn affidavit of complaint indicating an unknown person entered into his safe and did steal \$400,000 worth of silver one dollar coins. The victim further stated the last time he personally opened the safe prior to August 30, 2018 was sometime in November 2017.

The witness, Brenda Barnes, stated the victim had been over to the residence several times, but only new the victim had actually opened the safe in November 2017 prior to the victim opening it on August 30, 2018. The witness denied having any knowledge on who took the silver coins.

I made contact with the defendant and conducted a non-custodial interview to which he confessed to taking the silver without the victim's permission or knowledge. The defendant was mad at the victim for all the suffering he had caused his mother during their on-going divorce proceedings. The defendant stated he buried the silver one-dollar coins in three separate locations on the property owned by the victim. The defendant provided the locations of the buried silver coins. During post-Miranda, the defendant was read his rights and invoked his right to remain silent.

Based on the above facts, I have reason to believe and do believe the defendant, Stephen Aaron Earnes, violated Florida State Statutes 812.014(2a) Larceny Grand First Degree over \$100,000.
