### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On September 23, 2018 the 15 year old defendant, Hayden Fryday, did commit the criminal offense of F.S.S. 836.10 Write or Send Threat to Kill or Injure.

On September 24, 2018, a juvenile witness came forward to Crestview High School Administration advising that she had received threatening electronic messages from the defendant on September 23, 2018. The witness provided printed copies of the threatening messages to the School Resource Officer that explained how law enforcement was out at his residence a couple nights prior because it was believed he was going to kill or hurt someone. He also stated in this message "Every 1 is always making me getting to the point of where I'm gonna end killing sum1 or shooting up the school." The defendant went on to say, I don't know how much I can take of this because by everyday everyone is increasing my demon beasts and my demons like increasing their violence and destruction and aggression and rage and hatred. The defendant made several more concerning comments throughout this strand of messages talking about suicide and death.

During an interview with the defendant on September 24, 2018, he admitted that he did send the threatening messages to the witness but stated he didn't really plan to shoot anyone. The defendant advised he was feeling depressed at the time he sent the messages.

The witness completed a sworn written statement to the facts stated above and advised the threats made her worried for not only his safety but the safety of others as well.

This offense did occur in Okaloosa County and is a direct violation of F.S.S. 836.10 Write or Send Threat to Kill or Injure.
