[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On September 2, 2018, I made contact with a 2009 Silver Chevy HHR pulled over on the east side of Log Lake Road. I observed the defendant, Ladarius D. Perdue, standing next to the car. During the course of the investigation a co-defendant, Raheem Purdue, admitted, post-Miranda, that the vehicle was stolen and that it had been occupied by the defendant who had the knowledge it was stolen. The defendant's personal property was recovered from inside the vehicle.

An interview of a witness located at a local store placed the defendant inside of the stolen vehicle.

The victim, Amanda Gregory, completed a sworn affidavit of complaint reporting the vehicle stolen. Upon the recovery, the victim also reported the following missing from the vehicle;

Based on the facts of this case, I have reason to believe the defendant, Ladarius Perdue, committed the crime of Grand Theft of a Motor Vehicle, in direct violation of Florida State Statute 812.014.2c6, Burglary in direct violation of Florida State Statute 810.024, and Grand Theft of more than \$300, in direct violation of Florida State Statute 812.014.2c1.
