On December 22, 2016, your Affiant began working an Internet undercover operation to identify person(s) using peer-to-peer (P2P) software on the Internet to traffic in child pornography. Your Affiant knows from training and experience that peer-to-peer networks are frequently used in the trading of child pornography.

On December 22, 2016, your Affiant identified internet protocol address ██████████ in this investigation downloading and distributing child pornography using a peer-to-peer network.

On January 5, 2017, a subpoena was issued by the State Attorney's Office of the First Judicial Circuit in reference to the Internet service provider Cox Communication who leases the IP addresses to its customers. Cox Communication is the Internet Service Provider for the IP address ██████████ Your Affiant requested the account holder and associated information for the IP address ██████████ that was observed between December 22, 2016 and December 23, 2016.

On January 26, 2017, Jacqueline Murray, subpoena Specialist with Cox Communication responded to the subpoena service for IP address ██████████ Per the subpoena return the IP address ██████████ was leased between December 22, 2016 and December 23, 2016:

On March 10, 2017, the Honorable Judge Polson signed a search warrant for 216 Buck Drive NE Fort Walton Beach, Okaloosa County, Florida. On March 15, 2017, the search warrant was executed and digital evidence seized from the residence. Interviews were conducted on scene and recorded with a body worn camera.

During a review of the computer discovered in Jarred Pearce's room images of child sex abuse were discovered. The following is an example of the images discovered on the computer.

Based on the aforementioned information I have reason to believe and do believe Jarred Pearce did violate Florida State Statue 827.071.5 Possession of Child Pornography. This incident did occur in Okaloosa County Florida where your Affiant is a sworn Law Enforcement Officer.
