[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 10, 2018, at approximately 1420 hours, the defendant, John Thomas Stapleton (60 years old), in a lewd and lascivious manner intentionally touched the victim's back, upper buttocks, breast, and inner thigh area near her vagina underneath her clothing. The victim is a 6 year old female.

Witness, Dianne Barrett, provided a sworn written statement stating she watched a live recording of the 6 year old female victim being touched, in a lewd manner, underneath her clothing by the defendant.

Post Miranda, the defendant admitted to touching the victim underneath her clothing but denied touching her vagina area. The defendant advised the victim stated "it felt good" when he touched her.

Based on the above stated facts, I have reason to believe and do believe the defendant, John Stapleton, violated Florida State Statute, F.S.S 800.04 (5b) Lewd or Lascivious Molestation (victim <12 years old). This offense occurred at a hurricane shelter, during a state of emergency, located at Davidson Middle School, in Okaloosa County, where I am a sworn Criminal Investigator with the Office of the Sheriff.
