[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Tuesday, October 2, 2018, Investigators with the Okaloosa County Sheriff's Office Special Investigation Squad executed a search warrant at 310A Allen Street, Niceville, Okaloosa County, Florida. The resident at this address was identified as Mitchell Malaka McNabb who was taken into custody for warrants pertaining to narcotic and weapon offenses. It is to be noted, this address is within 1000 feet of the First Baptist Church of Niceville located at 622 Bayshore Dr, Niceville, FL.

Pursuant to the search warrant, Investigators recovered three firearms, including a Taurus PT738 .380 caliber pistol (SN: 65379A); a Ruger LCP .380 caliber pistol (SN: 371110259); and an IWI Uzi .22 LR caliber pistol (SN: W1023502). The Ruger LCP had been reported stolen under OCSO Offense Number OCSO170FF002200. These three firearms were recovered from a silver colored Honda under McNabb's control. From inside the maroon Toyota operated by McNabb, Investigators recovered approximately 72 dosage units and 32 fragments of pills marked "G3722" and "P039". These pills were identified as Alprazolam. Investigators further recovered 2 dosage units of MDMA, 6.5 grams of cocaine base (crack cocaine), 15 grams of cocaine HCL (powder cocaine), and 5.5 dosage units of a white pill marked "G 037" and identified as Hydrocodone/ Acetaminophen 10mg/325mg. From that same vehicle, Investigators found 3 grams of marijuana and 50 dosage units of a blue pill marked "A 215". These pills did field test positive for fentanyl and weighed approximately 5 grams. From inside the residence, Investigators found 50 grams of marijuana with some of it packaged for distribution. Investigators found 42 vapor cartridges containing THC. Documents addressed to McNabb and multiple items of paraphernalia including packaging materials, a metal grinder, and scales with residue were also found during the search.

A records check of McNabb's Criminal History shows he has 10 prior felony convictions. Among these, McNabb has been convicted for Possession of Weapon or Ammo by Convicted Felon (2016); Cocaine Possession (2017, 2012); Trafficking in Illegal Drugs (2011); and Driving While License Suspended or Revoked-Habitual Offender (2012). The investigation further revealed McNabb has resided at 310A Allen Street in Niceville for approximately 6 months and had control and unrestricted use of the silver Honda.

Based on a totality of the circumstances, I have probable cause to believe Mitchell Malaka McNabb violated Florida State Statute 790.23(1) in that he did willfully, knowingly, and feloniously possess three firearms as a previously convicted felon. I have probable cause to believe Mitchell McNabb violated Florida State Statute 893.135(1e4a) in that he was willfully, knowingly, and feloniously in possession of approximately 5 grams of fentanyl. I have probable cause to believe Mitchell McNabb violated Florida State Statute 893.13(1e2) on for separate counts in that he was willfully, knowingly, and feloniously in possession of 20.5 grams of cocaine and cocaine base, 63 grams of marijuana, 2 dosage units of MDMA, and 42 THC vapor cartridges with the intent to distribute these items while within 1000 feet of the First Baptist Church of Niceville. I have probable cause to believe Mitchell McNabb violated Florida State Statute 893.147 in that he did willfully, knowingly, and unlawfully possess materials used to store, package, weigh, ingest, and distribute narcotics. These offenses occurred in Okaloosa County where I am a sworn law enforcement officer.
