[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 6, 2018, the honorable Judge Angela Mason read and signed a search warrant for the residence at 212 Angelfish Avenue Unit 4, Fort Walton Beach, FL.

On October 6, 2018, your Affiant and other members of the Okaloosa County Sheriff's Office served the lawfully obtained search warrant at 212 Angelfish Avenue Unit 4, Fort Walton Beach, FL.

Prior to serving the warrant, it was determined that the occupants of the residence were the defendant, Favian Lestat Pabon, and the codefendant, Leeann Summer Pabon. Additionally, during the search, several documents containing the defendant's and codefendant's name were located throughout the residence.

During the search of the residence, deputies located more than one pound of marijuana in several different packages, including baggies, corner baggies, and vacuum sealed bags. Several of the bags were located in the kitchen on the counter and in the only bedroom with a bed. In the bedroom closet, deputies located three actively growing cannabis plants with lights set up above them. In two rooms of the residence, deputies located several cannabis seeds. Deputies also located several items of paraphernalia, to wit; marijuana grinders, glass smoking devices, and digital scales.

Per your Affiant's training and experience, the amount of marijuana and number of packages of marijuana are indicative of the distribution of marijuana. Also, per your Affiant's training and experience, it was apparent the defendant and codefendant were cultivating cannabis plants with the use of lamps, soil, and pots.

One baggie of marijuana was field tested and provided a presumptive positive result for the presence of THC.

Based on the above information, your affiant has reason to believe and does believe the defendant, Favian Lestat Pabon, did unlawfully violate F.S.S. 893.13(1)(a)2 - Possession of Marijuana with Intent to Distribute; F.S.S. 893.13(1)(a)2 - Cultivation of Marijuana; and F.S.S. 893.147(1) - Possession of Drug Paraphernalia. These offenses occurred in Okaloosa County, Florida where your Affiant is a sworn law enforcement officer.
