[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On November 8, 2018, the victim, Jessica Cody reported her 1997 Nissan sedan, bearing Florida tag 848PVW, stolen out of Santa Rosa County Sheriff's Office, case number 18-011161.

On November 9, 2018, I observed the above mentioned vehicle parked on the side of the interstate near MM 47, Holt, Okaloosa County, Florida, with the defendant, Latrell Damontrey Husfelt, and the (4) co-defendants were walking away from the area. When I activated my lights, Simmons and the co-defendants fled on foot and ran into the woods. The tag number was provided to Okaloosa County Communication Personnel and they indicated the vehicle was reported stolen.

A perimeter was setup and while waiting on K9 deputies to arrive on scene, 2 of the co-defendants stepped out of the woods where deputies noticed them at MM 46. Deputies gave lawful verbal commands and they failed to comply. The 2 co-defendants fled back into the woods, however, one of the co-defendants were apprehended.

K9 Deputies conducted a track where they located 3 of the co-defendants near the fence area, approximately 100 feet into the woods.

Approximately 10 minutes later, deputies noticed a light coming out of the wooded area near the Holt exit (exit 45). This is close proximity from where the subjects were seen at MM 46. When this subject exited the woods, he matched the description provided by other deputies. This subject was taken into custody without further incident.

Post Miranda, Husfelt and one other co-defendant indicated they were picked up by one of the co-defendants and drove to a residence located in Crestview. They then left that residence where they drove towards Holt. However, the vehicle broke down and the vehicle was left on the side of the road. While standing near the vehicle, they observed a patrol vehicle and fled on foot into the woods.

Post Miranda, another co-defendent indicated he stole the vehicle and went driving around with the co-defendants. The vehicle had an oil leak and the vehicle was parked on the side of the road. He stated when he got out of the vehicle, he threw the vehicle's key into the woods, where it was later recovered by K9 deputies.

Based on the above facts, the defendant, Latrell Damontrey Husfelt, violated the provisions F.S.S 812.014(2)(c)6) grand theft of a motor vehicle and F.S.S 843.02 resisting officer without violence.
