[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

The Defendant Felicia E. Freeman did commit the criminal offense of Child Neglect without great bodily harm, pursuant to Florida State Statute 827.03(2)(d).

This offense is evident by video footage and testimony from Sergeant Heath Hehl.

Freeman was traveling East on Airport Road in a Chevrolet truck bearing Florida License Plate 7025 YT. The truck crossed the center line directly into the path of Sergeant Heath Hehl who was traveling West on Airport Road in his marked patrol vehicle. Sergeant Hehl had to run off the North side of the road to avoid a head-on collision with Freeman. Freeman's vehicle was entirely in the westbound lane of travel, traveling East. At no point did Freeman make an attempt to avoid a head-on collision and continued East in the westbound lane for a short distance.

The video footage shows [redacted] sitting in a lawn chair in the center of the truck. [redacted] also was not belted into the chair nor was the chair secured in the vehicle as a factory seat would have been.

The act of not having the child properly secured in a seat with the proper safety restraints shows a neglect of the child's well being or a substantial risk of great bodily harm.

It should be noted Freeman was arrested for DUI pursuant to Florida State Statute 316.193 and provided two breath samples of 0.150 g/210L and 0.146 g/210L.

This offense did occur in Okaloosa County where I am a full-time sworn law enforcement officer.
