Investigators with the Okaloosa County Sheriff's Office identified the defendant outside an establishment and attempted to detain him for the above investigation. When investigators approached the defendant, they activated their blue emergency lights in their vehicle. An investigator, wearing a sheriff's office badge, repeatedly ordered the defendant to get on the ground, stating, "Sheriff's office, get on the ground". The defendant did not comply and the defendant was taken to the ground where he continued to resist by not placing his hands behind his back as ordered.

Based on the above-mentioned facts and totality of the circumstances, I have probable cause to believe the defendant committed the offenses of Grand Theft Auto and Resisting Arrest without Violence. This offense occurred in Okaloosa County, Florida and violates F.S.S. §12.014 (2c6) and 843.02.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 11/18/2018, the defendant, Mary Angela Denise Mulcahey committed the offense of Grand Theft Auto based on the following:

During the course of a death investigation with suspicious circumstances, I learned the co-defendant was unlawfully in possession of the victim's vehicle. In a post-Miranda interview, the defendant admitted the co-defendant arrived on 11/18/2018 and picked her up in this vehicle from a location in Mary Esther, FL. The defendant admitted there was concern the vehicle was stolen. Due to this concern, the defendant stated the co-defendant placed a license plate that belongs to the defendant's father (from another vehicle) onto the vehicle to avoid detection.

On 11/19/2018, the defendant committed the offense of Possession of Drug Paraphernalia based on the following:

Upon the defendant being taken into custody, her purse was found discarded in the area she was detained. A search of this purse resulted in locating a used syringe. During a post-Miranda interview, the defendant admitted the purse was hers, that she discarded it when law enforcement took her and the co-defendant into custody. The defendant further admitted the syringe was used to inject illegal narcotics, specifically Heroin. In addition, located within the purse were the keys to the vehicle described above.

Based on the above-mentioned facts and totality of the circumstances, I have probable cause to believe the defendant committed the offenses of Grand Theft Auto and Possession of Drug Paraphernalia. This offense occurred in Okaloosa County, Florida and violates F.S.S. §12.014 (2c6) and 893.147 (1).
