[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 11/26/18 at 2333 hours, I responded to the intersection of Beal Pkwy and Hospital Drive, in Fort Walton Beach FL. For an intoxicated driver.

Upon my arrival, I made contact with a black male, later identified as Camrin J. Mack, unconscious behind the wheel of a motor vehicle. I noticed the vehicle was in drive, and Mack's foot was on the brake. The vehicle began to roll, and Mack awoke and placed the vehicle in park, and exited the vehicle. Multiple pill bottles were observed in the vehicle that do not belong to Mack. Mack was detained, and read Miranda. Mack agreed to speak and advised he is tired, and trying to make it home. A pat down was conducted on Mack. Located in Mack's left pant pocket is as follows:

- 5 small baggies containing suspected heroine that were field tested and gave a presumptive positive result for Heroin.
- A baggie containing suspected marijuana that was field tested and gave a presumptive positive result for marijuana.
- A baggie containing suspected Methamphetamine. A field test was conducted and gave a positive result for meth.

Based on my investigation, I have reason to believe and do believe Camrin J. Mack violated the following Florida states statues:

- FSS:893.13.6a Possession of Heroin FSS:893.13.1a1
- Possession of a controlled substance to whit Methamphetamine
- Possession of Marijuana less than 20 grams FSS:893.13.6b

These offenses occurred in Okaloosa County where I am a full time, bonded, sworn law enforcement officer.
