[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 12/2/18, an investigation of a possible retaliation for a recent shooting took place involving a white Mercury Grand Marquis containing three armed black males as the suspect vehicle. On 12/3/18 in the early morning hours, a shooting took place in an area where possible victim is known to frequent. While the scene investigation was being conducted, the suspect vehicle slowly drove past the scene with four black subjects inside.

A Terry Stop was attempted on the white in color, 2005 Mercury Marquis bearing Florida tag # 4805BQ, by D/S Trimboli at the intersection of Bob Sikes Blvd. and Playground Rd. After a vehicle pursuit, reaching speed of 100 MPH, the vehicle came to a final rest at 100 Museum Dr, Eglin AFB, Florida.

The odor of marijuana was emitting from inside the vehicle. The driver's side, rear passenger was identified as the Defendant, SEBASTIAN KALEB ORR. During a probable cause search of the vehicle, a firearm was located concealed in the driver's side, rear passenger floor board, not encased, readily accessible to SEBASTIAN. The firearm was removed and identified as a Glock 42 .380, containing a loaded magazine with a round in the chamber.

The above actions of SEBASTIAN KALEB ORR are in violation of the following:

On 12/2/18, an investigation of a possible retaliation for a recent shooting took place involving a white Mercury Grand Marquis containing three armed black males as the suspect vehicle. On 12/3/18 in the early morning hours, a shooting took place in an area where possible victim is known to frequent. While the scene investigation was being conducted, the suspect vehicle slowly drove past the scene with four black subjects inside.

A Terry Stop was attempted on the vehicle by D/S Trimboli at the intersection of Bob Sikes Blvd. and Playground Rd., but the vehicle accelerated by D/S Trimboli's vehicle. The vehicle accelerated to a high rate of speed through a residential and a pursuit ensued. The vehicle refused to stop with three marked patrol vehicles behind it with their emergency lights and siren activated. Once out of the residential area, the vehicle accelerated to speeds over 100

mph on Eglin Pkwy., Shalimar. The vehicle continued until it spun out on an overpass near the Air Force Armament Museum. Once the vehicle was back under the control, it drove off road underneath an airplane and was boxed in by law enforcement. All parties were detained.

The odor of marijuana was emitting from inside the vehicle. The front passenger was identified as the Defendant, Jazmaine Shipman. During a probable cause search of the vehicle, a firearm was located concealed on the front passenger side floorboard behind a black bag, which was under the feet of the defendant where only she was able to access the firearm. The firearm was not encased, readily accessible to the defendant. The firearm was removed and identified as a Glock 19 9mm, containing a loaded magazine without a round in the chamber. The firearm is reported stolen out of Fort Walton Beach Police Department. A glass jar containing suspected marijuana was also located on the floorboard next to the black bag. A field test was conducted on the suspected marijuana and it yielded a positive result for THC. The marijuana was later weighed for a total of 19 grams without packaging. The black bag next to all the items found was identified as belonging to the defendant due to having her current Florida identification inside.

Post Miranda the defendant denied knowledge of the firearm, but admitted to possession of the marijuana.

The odor of marijuana was emitting from inside the vehicle. The passenger side, rear passenger was identified as the Defendant, MALEAK RAMAIRE BRADSHAW. During a probable cause search of the vehicle, a digital scale was located in the rear pouch of the seat in front of BRADSHAW and field tested positive for Marijuana. A second scale was located under BRADSHAW's person. This scale field tested positive for Marijuana and Methamphetamine. A firearm was located concealed under the passenger seat, not encased, readily accessible to BRADSHAW.
