[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On December 4, 2018, the defendant, Tyler Lee Touchstone, committed the offense of armed burglary pursuant to F.S.S 810.02(2)(a), possession of burglary tools pursuant to F.S.S 810.06, unlicensed carrying of a concealed weapon F.S.S 790.01(2) and possession of a firearm during the commission of a felony F.S.S 790.07 (2) within Okaloosa County, Florida.

On December 4, 2018 Deputy Gorski received a call for a suspicious person wearing a gray and red hooded sweatshirt and carrying a flashlight and gas can on Lost Horse Circle, Niceville, Florida. I responded as backup and we began canvassing the area for a white male wearing the described hooded sweatshirt. Deputy Gorski was stopped by a passing motorist and told that a suspicious male in a hooded sweatshirt was located at 4243 Lost Horse Circle, Niceville, Florida. Upon arrival we witnesses the defendant partially inside of a silver Mercedes Benz parked at 4247 Lost Horse Circle. The defendant had a flashlight and a gas can and was using the flash light to look through the vehicle. The male was detained and was found to be in possession of a 9mm Beretta pistol in his right pocket, a flashlight, a multi tool with what appeared to be a glass punch, and a bandana around his neck in a way it would be used to cover his face. Contact was made with Jennifer R. Williams, the home owner and owner of the vehicle. Williams stated she did not know the defendant and he did not have permission to be in her vehicle. Williams provided a sworn written affidavit of complaint.

Due to the evidence provided to me in this case, I have reason to believe and do believe the Defendant, Tyler Lee Touchstone, did violate F.S.S 810.02(2)(a) armed burglary, F.S.S 810.06 possession of burglary tools, F.S.S 790.01(2) unlicensed carrying of a concealed weapon and F.S.S 790.07 (2) possession of a firearm during the commission of a felony.

This occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.
