[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Sunday December 2, 2018 at approximately 1319 hours, I responded to TGI Friday's located at 547 NW Mary Esther Cutoff in reference to a domestic battery which occurred at 577 Florosa Ct. As a result of the ensuing investigation, the below listed probable cause was developed to support the arrest of the defendant, Dante Jermaine Dixon for the charges of Aggravated Battery and False Imprisonment.

At approximately 1200 hours, the victim Diamond Fleming arrived at her place of work, TGI Friday's showing signs of injury from what she described as a recent attack by the defendant, with whom she resides and has two children in common. Diamond disclosed to a coworker, Katlyn Rados the injuries had been caused by the defendant pulling her through their apartment, slapping her in the face several times, and striking her in the buttocks and rear of her legs with a 2x4 piece of wood. Diamond then left the business to bring her children to a safe location while Katlyn contacted law enforcement.

At approximately 1445 hours, Diamond returned to the business where I made contact with her. Diamond advised she questioned the defendant about another girl at which point he grabbed her by the neck of her shirt and began slapping her in the face with an open hand several times, all while holding The defendant continued to slap Diamond until she was able to get away and flee downstairs. Upon returning to the apartment out of fear, Diamond advised the defendant utilized a drawstring from his pants to tie her wrists behind her back, keeping her from fleeing or defending herself, and began striking her in the buttocks and rear of her legs with a wooden 2x4. Diamond advised she broke free from the tie only to turn around and again be struck in the face with an open hand, this time resulting in a cut upper lip. Diamond advised she was only able to get away by telling the defendant if she missed bringing the children to their grandparent's, they would contact law enforcement out of concern.

Diamond suffered several visible injuries consistent with her version of events, to include a cut upper lip which contained dried blood and was largely swollen and purple in color. Her neck and throat area contained several small scratches and her face was red and puffy around the eyes and cheeks. Diamond's inner right bicep region contained approximately 3 small circular bruises consistent with finger tips and small bruises to the bony area of her wrists where she advised the defendant had tied the drawstring in a knot. Finally, per Deputy Frembgen's supplement, Diamond suffered bruising, redness, and swelling to her right buttock and upper rear leg consistent with being struck by a large object. Diamond complained of pain in her lip and walked with a noticeable limp.

The defendant could not be located for the purpose of an interview.

As a result of the above listed findings of my investigation, I have probable cause to believe and do believe the defendant, Dante Jermaine Dixon struck the victim several times in the face against her will. Further, upon being able to flee the first incident, the defendant utilized a drawstring to tie the victim's arms behind her back in an attempt to keep her from defending herself and leaving the apartment with the intent to cause bodily injury or terrorize. These incidents, which occurred in Okaloosa County, FL where I am a sworn Law Enforcement Deputy, are violations of F.S.S. 784.045.1a2, Aggravated Battery DOMV, and F.S.S. 787.02.1a, False Imprisonment DOMV.
