

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On January 20, 2019, the defendant, Jason Bartlet, did knowingly and willingly commit the offense of Possession of Drug Paraphernalia.

This deputy conducted a traffic stop on a gold Buick, bearing Florida tag #N412GH after an NCIC/ FCIC check of the license plate revealed it was assigned to a red Honda SUV. The driver of the vehicle, Chelsea Cory, was later arrested for Driving While License Suspended or Revoked. Bartlett was the front seat passenger of the vehicle.

During an inventory of the vehicle, a glass smoking pipe was located under the defendant's front passenger seat. This smoking pipe field tested positive for the presence of methamphetamine.

In a post-Miranda interview, the defendant denied possession of the pipe.

Your affiant has reason to believe and does believe the offense is in violation of F.S.S. 893.147 Possession of Drug Paraphernalia. The offense did occur in Okaloosa County, Florida, where your affiant is a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On January 20, 2019, the defendant, Chelsea Cory, did knowingly and willingly commit the offenses of Possession of Marijuana, Possession of Methamphetamine, Trafficking of Methamphetamine, Possession of Paraphernalia, and Driving While License Suspended or Revoked (2nd offense.)

This deputy conducted a traffic stop on a gold Buick, bearing Florida tag #N412GH at 995 E US Highway 98, Destin, FL after an NCIC/FCIC check of the license plate revealed it was assigned to a red Honda SUV. The defendant was found to be the driver of the vehicle. Her Florida license not only had multiple active suspensions, but it was discovered she was previously convicted for Driving While License Suspended or Revoked on 2/13/2018 in Okaloosa County, Florida.

While conducting an investigation during the traffic stop, the defendant gave this deputy verbal permission to search a backpack that the defendant claimed was hers. The defendant stated there was a knife, a scale and hypodermic needles in her backpack. A search of the backpack revealed a scale, similar to those commonly used to weigh narcotics, and two hypodermic needles that field tested positive for the presence of methamphetamine.

During an inventory of the vehicle, I discovered a clear bag containing multiple smaller bags under the front driver's seat, in the immediate possession of the defendant. One of the smaller bags contained approximately 10 grams of a green leafy substance that field tested positive for tetrahydrocannabinol (THC). Also in the larger bag were four smaller clear bags that contained a white crystalline substance that field tested positive for methamphetamine. The suspected methamphetamine was found to weigh a total of 16 grams.

Your affiant has reason to believe, and does believe these offenses are in violation of F.S.S. 893.13.6b Possession of Marijuana less than 20 grams, F.S.S. 893.13.1a1 Possession of Methamphetamine, F.S.S. 893.135.1f Trafficking of Methamphetamine, F.S.S. 322.34.10b.2 Driving while License Suspended or Revoked (2nd offense), and F.S.S. 893.147 Possession of Drug Paraphernalia. These offenses did occur in Okaloosa County, Florida, where your affiant is a sworn law enforcement officer.




While conducting an inventory of the vehicle, a glass smoking pipe was located in a backpack on the rear floor board in between where the defendant's leg had been. The backpack and glass pipe were in the immediate possession of the defendant. The glass smoking pipe still had a consumable amount of a white crystalline substance that field tested positive for methamphetamine. The suspected methamphetamine was weighed and found to be one gram.

Post Miranda, Mosby denied possessing the bag or contraband.



On January 20, 2019, the defendant, Jason Polgar, did knowingly and willingly commit the offenses of Possession of a Controlled Substance without a Prescription (Alprazolam), Possession of a Controlled Substance without a Prescription (heroin), Trafficking in Heroin, and Possession of Paraphernalia.

This deputy conducted a traffic stop on a gold Buick, bearing Florida tag #N412GH after an NCIC/ FCIC check of the license plate revealed it was assigned to a red Honda SUV. The driver of the vehicle, Chelsea Cory, was later arrested for

Driving while License Suspended or Revoked. Polgar was the right rear passenger of the vehicle.

An inventory of the vehicle revealed a tan pouch under the front seat middle arm rest on the floor. Inside the case was a clear bag that contained a brown tar substance that field tested positive for heroin. There was also a small clear bag that contained 10.5 yellow rectangular pills that Drugs.com identifies as Alprazolam, a schedule IV drug. The suspected heroin was weighed and determined to be 7 grams, meeting the statutory weight for trafficking in heroin.

Post Miranda, the driver of the vehicle, Chelsea Cory, identified Polgar as the owner of the green bag containing the brown tar substance, and the yellow rectangular pills. Cory stated the defendant placed the tan pouch in the middle of the vehicle as they were being pulled over in an attempt to keep law enforcement from identifying the owner. Cory clearly identified the bag and the exact spot where it was found in the vehicle. She also stated the defendant was observed in possession of the tan pouch the previous day.

Post Miranda, the defendant denied possessing the bag.

Your affiant has reason to believe and does believe these offenses are in violation of F.S.S. 893.13.6a Possession of a Controlled Substance without a Prescription (Alprazolam), F.S.S. 893.13.1a1 Possession of Heroin, F.S.S. 893.135.1c1 Trafficking in Heroin, and F.S.S. 893.147 Possession of Drug Paraphernalia. These offenses did occur in Okaloosa County, Florida, where your affiant is a sworn law enforcement officer.
