[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 02/13/2019, at 1325 Greendale Avenue, Apt 43, Fort Walton Beach, Florida; the Defendant, Ian Wilde, violated F.S.S. 893.13(1a2), Possession of marijuana with intent to distribute, F.S.S. 893.135(1c4a), Trafficking in fentanyl (4 grams or more), 893.135(1f1), Trafficking in methamphetamine (14 grams or more), F.S.S. 893.13(6a), Possession of a controlled substance (to wit: THC extract), and F.S.S. 893.147(1); Possession of drug paraphernalia.

The Okaloosa County Street Crimes Unit conducted a warrant service at the aforementioned location in an attempt to locate the Defendant. Upon arrival, a subject exited the front door and the Defendant was observed walking to the rear of the residence. Further, the subject stated the Defendant was inside the residence. The odor of marijuana was detected emitting from within the residence.

The Defendant was given a lawful orders to lay on the ground and complied. OCSO Deputies entered the residence and detained the Defendant. While detaining the Defendant, a marijuana grinder was observed in plain view, on the living room table.

The Defendant was provided his Miranda Rights from an agency issued card. The Defendant agreed to speak with Deputies and stated he had marijuana and a digital scale in a kitchen cabinet. The Defendant was asked and granted consent to search the residence. During a consensual search of the kitchen, approximately one gram of marijuana and the digital scale was located within the kitchen cabinet. Also located within the kitchen cabinet, were several small bags and a vacuum sealed bag containing marijuana residue.

A search warrant for the aforementioned location was prepared and approved by the Honorable John T. Brown.

During a search of the residence, the following items were located within a gun safe, located within a hall closet at the residence. The following item's weights are approximate.

- 259 grams of marijuana
- 237 grams of methamphetamine
- 6 grams of fentanyl
- 14 THC cartridges

Documents containing the Defendant's name were located inside of the gun safe along with the narcotics. Further, a phone box was located within the gun safe. A cell phone located within the Defendant's bedroom was matched and had the same IMEI number located on the phone box. Further, the described cell phone was the same model listed on the phone box. Also located within the gun safe was a large amount of US currency.

The methamphetamine was packaged into 8 individual 1 ounce bags and one 13 gram bag. Based on your Affiant's training and experience, the large amount of narcotics and US currency, along with the several bags; the items located are consistent with the distribution of narcotics.

Post Miranda, the Defendant denied knowledge of the items located within the gun safe and denied ownership of the gun safe.

The marijuana, methamphetamine, fentanyl, and THC cartridges were field tested, and rendered a presumptive positive for the presence of their described identities. The digital scale was field tested and rendered a presumptive positive for the

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 02/13/2019, at 1325 Greendale Avenue, Apt 43, Fort Walton Beach, Florida; the Defendant, Troy Magill, violated F.S.S. 893.13(6a); Possession of a controlled substance (to wit: methamphetamine).

The Okaloosa County Street Crimes Unit attempted a warrant service at the aforementioned location. Upon approaching the front door, the Defendant exited the residence and the odor of marijuana was detected emitting from within the residence. Further, the odor of marijuana was detected emitting from the Defendant.

During a probable cause search of the Defendant, approximately 3 grams of methamphetamine was located in the Defendant's right jacket pocket. A field test of the methamphetamine rendered a presumptive positive for the presence of methamphetamine.

Post Miranda, the Defendant stated he purchased the methamphetamine the day prior.
