[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 02/23/19 at about 2024 hours, I, Deputy Piaget, responded to 735 Martin Luther Jr. Blvd, Fort Walton Beach, FL in reference to a trespassing.

The COMPLAINANT, Jennifer Watkins, reported she wanted the DEFENDANT, TAYANNA SMITH, and suspect, JESSICA VINSON, to leave the business due to refusal to leave after several requests. I requested multiple times for the DEFENDANT and VINSON to walk outside the business to speak about the incident. The DEFENDANT refused to step outside and stated, "Why does she get authority? Am I rude". I advised the DEFENDANT and VINSON to step outside the business and both parties refused to exit the business.

At that time, I attempted to detain the DEFENDANT when she pulled away from me and started running out the front door of the business. Vincent attempted to block my path to detain the DEFENDANT by standing in front of me and yelling, "Stop, stop, stop!"

When the DEFENDANT ran out of the front door of the business, I was able to grab her shirt at which time the DEFENDANT turned and started striking my face with closed fists. During this physical altercation, I retrieved my agency issued pepper spray and the DEFENDANT slapped the pepper spray out of my hands depriving me from my weapon to defend myself from further strikes. During this altercation with the DEFENDANT, I gave multiple commands for the DEFENDANT to stop however she did not adhere to my lawful commands .

The DEFENDANT entered the passenger side of a 2007 white Mercedes (FL tag 10477Z) to attempt to elude law enforcement. I retrieved my pepper spray off the ground and opened up the front driver side door of the vehicle. The DEFENDANT exited out the vehicle and refused to obey lawful commands to step out from behind the vehicle . The DEFENDANT was sprayed in the facial area with pepper spray and ran to around parked vehicles towards Martin Luther King Parkway. A WITNESS, STEVEN KRAUSS, witnessed the physical incident and grabbed the DEFENDANT while she attempting to escape until I was able to detain the DEFENDANT.

During the physical altercation with the DEFENDANT, my prescription glasses was broken into multiple pieces caused by the DEFENDANTS strikes to my face. The prescription glasses total costs were approximately \$500.00.

The COMPLAINANT wished to pursue charges for trespassing and completed an Affidavit of Complaint was completed.

Based on the above, your Affiant has probable cause to believe the DEFENDANT, TAYANNA SMITH, did violate F.S.S. 843.025, Deprive of Means of Protection or Communication; F.S.S. 806.13(1B2), Criminal Mischief; F.S.S. 784.07(2B), Battery on LEO; F.S.S. 843.01, Resisting With Violence, and F.S.S.810.08(2A), Trespass After Warning.
