[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February, 3rd, 2019, the defendant, Donald Edward Anderson, knowingly violated Florida State Statute 856.021 Prowling. The following will describe the defendant prowling in a place, and in a manner not usual for law-abiding individuals, under circumstances that warrant a reasonable alarm and immediate concern for the safety of children.

I made contact with (15 years old) and (16 years old) at Poplar Ave, Fort Walton Beach, Florida.

stated the following: In early January, a man in a Red Chevrolet Astro Van, later identified as the defendant, was riding through the neighborhood trying to offer other children cookies and candy. Today saw the defendant following her. She took a picture of his license plate, Georgia Tag PAR3699. She has seen the defendant driving around the neighborhood approximately 3 times per week for a month.

The license plate was searched through NCIC and revealed the defendant as the registered owner.

stated the following: January, 21, 2019, in the area of Poplar Ave, the defendant followed her around in his Red Chevrolet Astro Van. The defendant offered her cookies and candy. The defendant also followed her and a friend on multiple different occasions. She identified the defendant as the same person saw on February 3, 2019 in the Red Chevrolet Astro Van. She has seen the defendant talk to other children that were approximately 6 to 10 years old.

The defendant stated the following after being read his Miranda Rights. He lives in Georgia but has been in the area for one month. He was trying to take a short cut through the neighborhood and was going to the mall. He was staying at the Rocky Bayou State Park in Niceville, Florida. He has only been in this neighborhood once before.

The defendant's statement then changed when again asked if he had been in the neighborhood before. He may have been in the neighborhood a couple of times before, but only once today. He likes to drive around a lot.

After the defendant was told there was a picture of him being in the area earlier today, he stated the following: He may have been in the neighborhood earlier and a total three or four times in the last month.

After the defendant was asked why he has been on Poplar Ave multiple times this month, he stated the following: He enjoys driving in the low income areas and looking at the people. He is a people watcher and drives around looking at people.

The defendant denied offering cookies or candy to anyone.

The distance between Rocky Bayou State Park and ☒ Poplar Ave is a 26 minute drive. It should be noted all of the streets near the incident location use Lovejoy Road as a point of entry and exit. There is no way to drive through the neighborhood as a shortcut.

This offense occurred in Okaloosa County where I am a sworn law enforcement officer.
