

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 3/15/2019, Okaloosa County Sheriff's Office (OCSO) deputies arrived at 359 Bullfish Avenue, Unit 4, Fort Walton Beach, Florida as they received a tip that the defendant, Jeffrey Lee Sowell, was inside the residence and possessed an active felony warrant for sexual battery and domestic violence battery by strangulation.

When deputies approached the house, the defendant was walking outside of the residence and upon sight of law enforcement, immediately fled back into the residence. When the responding deputies created a perimeter of the residence, the defendant attempted to exit the back door and flee. When the defendant saw law enforcement, he returned inside. The defendant was then seen climbing on the roof of the residence attempting to flee from the deputies. The defendant then was ordered to come down to ground level and comply with law enforcement commands and be taken into custody. The defendant resisted by refusing to listen to commands by turning his head away from deputies and walking away. The defendant slid down off of the roof and hung from an adjoining wall to neighboring residence (359 Bullfish Avenue, Unit

9). The homeowners of 359 Billfish Avenue, Unit 9 were in the residence when the defendant was hanging from the adjoining wall of their residence. The homeowners demanded the defendant to leave the property. The defendant refused to leave the property and opened a sliding glass door and entered the residence willfully without authorization or invitation and walked into the garage. The homeowners confronted the defendant in the garage with weapons to protect themselves and demanded the defendant to leave once again. The homeowner opened the garage door to which the defendant fled the residence. The defendant then ran from the area on foot until which time he was observed by an OCSO Marine Unit running westbound along the Santa Rosa Sound. An OCSO Beach Unit in full uniform gave chase behind the defendant giving verbal commands to stop. Upon hearing the verbal commands, the defendant stopped running due to verbal commands being given and was ordered to the ground to be taken into custody.

Post-Miranda, the defendant stated he did not know he had a warrant but did not know why law enforcement was there for him and fled for that reason.

Based on the above, I have reason to believe and do believe that the defendant, Jeffrey Lee Sowell, did commit and violate Florida State Statute 843.02 - Resisting Without Violence and Florida State Statute 810.08.2b - Trespassing in an Occupied Structure/Conveyance. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
