

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 25, 2019 I was contacted by Brandon Carrier and advised he was supposed to be meeting his ex-wife to drop off their child. He was concerned after speaking with her on the phone that she was slurring her speech and not making sense. I located his ex-wife, Analise Guillen, (the defendant) at approximately 1400 hours in the parking lot of the Destin-Fort Walton Beach Airport.

The defendant was seated in the driver' seat of her vehicle with it turned on while we spoke. During our conversation, the defendant appeared disorientated and confused as she couldn't correctly tell me the date or day of the week. The defendant admitted to ingesting prescription medications that could have impaired her judgment earlier in the day. During our contact the defendant's speech appeared to be slurred. Based on my observations I requested assistance from Deputy Jay Lieb with a DUI Investigation. Deputy Lieb conducted Field Sobriety Test and based on his observations, the defendant was placed under arrest for DUI. The defendant had three small children in the vehicle at the time I made contact with her.

The defendant subsequently provided a sampling of her breath in which the results of the sampling were .375 and .378 grams of alcohol per 210 liters of breathe.
