[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 03/27/2019, at 0327 hours, I responded to the area of 502 Gulf Shore Drive in Destin, Florida, in reference to a burglary in progress. Initial information indicated two white males, wearing black in color hoodies, with hoods drawn over their heads, and grey sweat pants were seen in the area burglarizing vehicles. Witnesses observed these two males attempting to enter a parked unattended vehicle in the driveway of 105 Durango Road by tugging on the doors, but noticed their entry was ultimately unsuccessful at this location. Additionally, the witnesses observed both males then successfully make entry into a silver in color Chevy Silverado pick-up truck, parked in the driveway of 501 Gulf Shore Drive #8. After entering the vehicle and departing the residence, both males then began to walk west on Gulf Shore Drive until the witnesses lost sight of both subjects.

A short time after the initial information was received, units converged in the area and ultimately located the defendant, Dennis James Bosarge, and co-defendant, Brennan Paul Johnson, in the parking lot of Norriego Point, located at the end of Gulf Shore Drive. Both Bosarge and Johnson matched the description that was provided by the witnesses. They were both stopped and advised of their legal rights pursuant to Miranda before any questioning. Both individuals waived their rights and claimed they had only walked down the main road looking for assistance in getting their friend's broken down car back running.

On 03/27/2019, at 0327 hours, I responded to the area of 502 Gulf Shore Drive in Destin, Florida, in reference to a burglary in progress. A show up was conducted with all witnesses individually and all identified both Bosarge and Johnson as the individuals seen attempting entry of the vehicle at 105 Durango Road and successfully entering the silver in color Chevy Silverado at 501 Gulf Shore Drive #8.

Contact was made with the Chevy Silverado's owner, who indicated his vehicle had been entered and rummaged through, but nothing was taken.

During a search of Johnson's person, a clear plastic baggie containing one gram of marijuana was located in his front left pants pocket. This marijuana later field tested positive.

During the investigation, it was determined that Johnson was present with additional co-defendants, Emily Bujol and Landon Mcraney, at the parking lot of the East Pass. Bujol and Mcraney were present sitting within a red in color Chevy HHR, four door sedan, bearing Louisiana License #H409595. A strong odor of marijuana was detected emitting from the interior of this vehicle. During a search of the vehicle, a Glock 43 9mm subcompact pistol, Serial #ZNY842 was located. The weapon was in a holster, loaded with a six round magazine, stuffed within a large toilet paper roll and covered by a hat, resting in the middle of the backseat of the vehicle. A check of the firearm's serial number revealed it had been reported stolen out of the Livingston Parish Sheriff's Office in the State of Louisiana.

Also located resting on the front center console dash compartment of the vehicle was a clear plastic baggie containing 16 grams of marijuana, which later field tested positive.

Johnson was questioned about these items post Miranda. He related that he purchased the firearm in "the hood" in Baton Rouge, Louisiana for \$180.00, and admitted that he had exclusive possession of the firearm since leaving Louisiana. Additionally, Johnson admitted to being possessing and bringing the stolen firearm into the State of Florida and the Destin area. During questioning, Johnson corroborated the location of the firearm in the vehicle as well as the manner it had been concealed. When questioned about the marijuana located within the vehicle, he initially denied having knowledge of it, and claimed the only marijuana he possessed was on his person. He later related that the marijuana found in the vehicle could also be "put" on him as he felt no one else would take responsibility for the contraband.

These offenses are in violation of F.S.S. 810.02.4b Burglary to Conveyance (unarmed / unoccupied), F.S.S. 812.014(2c5) Grand Theft of Firearm, F.S.S. 893.13(6b) Possession of Marijuana Not More Than Twenty Grams, and F.S.S. 856.021 Loitering and Prowling, and did occur in Okaloosa County, Florida.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 3/27/2019, I responded to the area of 502 Gulf Shore Drive, Destin, Florida in reference to a vehicle burglary in progress. Information indicated two white males, wearing black hoodies and grey sweat pants were seen in the area burglarizing vehicles.

While searching the area, the subjects were located at the entrance to Norriego Point with the defendant, Emily Bujol. The defendant and her boyfriend were observed sitting in her vehicle described as a red 2010 Chevrolet HHR bearing Louisiana registration H409595, with the defendant seated in the driver's seat. Upon talking to the defendant while she was present inside of the vehicle, a strong odor of marijuana was detected emitting from the interior.

During a probable cause search of the vehicle, a clear plastic baggie containing marijuana was located in a front center console dash compartment area, within the defendant's control. Additionally, a blunt containing marijuana was located adjacent to the gear shift in between both driver and front passenger seat. Also, a marijuana grinder was located in the drivers door side pocket. All marijuana field tested positive. The total amount in the defendants possession was 17 grams of marijuana.

Post Miranda, the defendant admitted to having knowledge of the marijuana inside of her vehicle and having

knowledge of it being concealed. The defendant also admitted that she works at a strip club and a customer of hers had bought her the marijuana grinder.

This is in violation of F.S.S. 893.13(6b) Possession of Marijuana Not More Than Twenty Grams and F.S.S. 893.147.1 - Possession of Drug Paraphernalia, and did occur in Okaloosa County, Florida.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 3/27/2019, I responded to the area of 502 Gulf Shore Drive, Destin, Florida in reference to a vehicle burglary in progress. Information indicated two white males, wearing black hoodies and grey sweat pants were seen in the area burglarizing vehicles.

While searching the area, the subjects were located at the entrance to Norriego Point with the defendant, Landon Mcraney. The defendant and his girlfriend were observed sitting in her vehicle described as a red 2010 Chevrolet HHR bearing Louisiana registration H409595 with the defendant seated in the front passenger seat. Upon talking to the defendant inside the vehicle, a strong odor of marijuana was detected emitting from the interior.

During a probable cause search of the vehicle, a clear plastic baggie containing marijuana was located in a front center console dash compartment area, within the defendant's control. Additionally, a blunt containing marijuana was located adjacent to the gear shift in between both driver and front passenger seat. All marijuana field tested positive. The total amount in the defendants possession was 17 grams of marijuana.

Post Miranda, the defendant admitted to having knowledge of the marijuana inside of the vehicle and having knowledge of it being concealed. The defendant also admitted that his friend, Brennan Johnson, gave him the marijuana to conceal in the vehicle to hide it from law enforcement.

This is in violation of F.S.S. 893.13(6b) Possession of Marijuana Not More Than Twenty Grams, and did occur in Okaloosa County, Florida.
