On 4/11/19, at approximately 2004 hours, Defendant traveled from Fort Walton Beach, Florida to a predetermined location for the purpose of engaging in sexual activity with a person he believed to be a 14 year old female. During conversations between the Defendant and the undercover officer, posing as the 14 year old female, the Defendant did solicit the child to engage in sexual activities with him. The predetermined location was given to the Defendant via text message. At approximately 2020, the Defendant arrived at the predetermined location and was taken into custody.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 4/10/2019, the defendant, Sandor Spitzmuller entered into a conversation via text message with an undercover officer posing as a thirteen-year-old female. During this conversation, the defendant began talking about sexual acts, stating, "No sex just I licking your p...y and masturbates". The defendant further described the size of his penis and stated, "I just game your pussy in my finger and my tongue. I really slow put in your pussy my dick". These conversations were facilitated via text messages.

On 4/11/2019 at approximately 2200 hours, the defendant traveled from Destin, Florida to a predetermined location to meet the thirteen-year-old female at which time he was arrested. In a post-Miranda interview, the defendant confessed to knowingly meeting a thirteen-year-old female was wrong. The defendant further confessed his intent was to

sexual activities with him. The predetermined location was given to the Defendant via text message. At approximately 1700 hours, the Defendant arrived at the predetermined location and was taken into custody.

While being taken into custody, the Defendant was found in possession of a concealed 9mm handgun. The firearm was concealed in his right front pants pocket, with a round in the chamber and readily available for immediate use.

Post Miranda, the Defendant admitted to using his cellular phone to text the 14 year old girl. The Defendant told her he would teach her sexual acts. The Defendant told the 14 year old he would teach her "How to ride. Bjs. Doggy. Etc". The Defendant described "riding" as the girl on top, "Bjs" as blow jobs and "Doggy" as on all fours from behind. The Defendant stated he agreed to pick the 14 year old up at the predetermined location.

Based on the aforementioned stated facts, I have reason to believe and do believe the Defendant Bryan Michael Weinstein violated F.S.S. 847.0135(3)(a) Use of a Computer to Solicit a Minor, F.S.S. 847.0135(4)(a) Traveling to Meet Minor for Sex, F.S.S. 934.215 Use of Two Way Communication to Commit a Felony and F.S.S. 790.07(2) Possession of Firearm During Commission of Felony. 

activity with a person he believed to be a fourteen (14) year old female. During conversations between Ford and the undercover officer who was posing as the fourteen (14) year old female, Ford did solicit the child to engage in sexual activities with him, such as sexual intercourse and kissing. The predetermined location was given to Ford via text message. At approximately 2325 hours, Ford arrived at the predetermined location and was taken into custody.

During an inventory search, deputies located less than one (1) gram of Marijuana in the cup holder of Ford's 2006 Ford F-150 bearing FL registration KGQU99. Ford does not have a medical marijuana card. The marijuana field tested positive for THC utilizing a presumptive field test.
