After the second time of passing the location, the defendant text the undercover officer and told them he just passed by. The defendant departed the area where he was stopped and arrested. The defendant was advised of Miranda which he invoked his right to legal counsel.

Based on the above-mentioned facts and circumstances, I have probable cause to believe the defendant committed the offenses of Using a Computer or Electronic Device to Seduce/Solicit a Minor, Traveling to Meet a Minor for Sex, and Use of a Two-Way Communication Device to Commit a Felony.
