[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On April 23, 2019, the 14 year old defendant, Kyron L Watts, did commit the offense of Possession of a Concealed Firearm, and Possession of a Firearm on School Property.

On the above mentioned date, I received information Watts may have been involved in a armed robbery on April 22, 2019 in Shalimar, FL involving the use of a silver revolver with a brown handle. I made contact with Watts to verify he was not in possession of a firearm on school grounds. Watts was in room 406 for 4th period. I escorted Watts out of room 406, and into the kitchen in room 406. Sgt Weeks was with me and we walked into the handicap restroom, and I conducted a pat down of Watts clothing. During the pat down Watts asked what was the problem, and I advised we had information he may be in possession of a firearm. After asking again, Watts stated he did have a gun and it was in his back pack. Sgt. Weeks located Watt's back pack next to his desk in the classroom, and secured the back pack. Sgt. Weeks watched Watts as I searched the bag, and in the main compartment of the back pack I located a Titan Tiger .38 Special revolver, silver with a brown handle, loaded with five (5) rounds of ammunition. The back pack also contained Watt's books and other personal items.

This offense occurred on the premises of Ruckel Middle School located at 201 Partin Drive N. Niceville, FL.
