[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 5/16/19, the defendant, Joshua David Lawrence, did violate the following Florida State Statutes:

- 1. 948.06.A Probation Violation Felony VOP/VOCC
- 2. 790.23.1a Possession of weapon or ammo by convicted FLA felon.
- 3. 983.13.6a Drugs Possess controlled substance without a prescription.
- 4. 843.02 Resist Officer Obstruct WO violence.
- 5. 983.13.6b Marijuana Possess marijuana possession not more than 20 grams.

The defendant has a prior felony convictions on 7/1/2016, and multiple convictions on 1/6/2017.

During this incident, the defendant had an active Felony VOP Warrant.

On 5/16/19, the defendant's vehicle was observed by Sgt. Hehl at a gas station in Milligan, Florida. The vehicle was observed departed the gas station traveling north on Highway 4. Sgt. Hehl was unable to formulate probable cause to initiate a traffic stop. The vehicle then turned onto Foxhound Lane, and ultimately continued onto Dead End Rd. Sgt. Hehl followed the vehicle.

When the vehicle came to a stop at 5240 Dead End Rd, the defendant exited the drivers side of the vehicle. At this time, Sgt. Hehl confirmed the defendant's identity. He then gave the defendant verbal commands to stop and called him by name while doing so. The defendant then ran southbound into the wood line with Sgt. Hehl following. He was apprehended by Sgt. Hehl after a short foot pursuit. At the time, Sgt. Hehl was operating a marked patrol vehicle and wearing a marked agency uniform.

During a search of the defendants person, I located a small plastic bag containing a green leafy substance in the coin pocket located on the right side of his jeans. Based on my experience I identified this substance as marijuana. The substance was also field tested presumptive positive for marijuana.

Prior to apprehension, Sgt. Hehl advised he smelled the odor of marijuana emanating from the GMC SUV as he passed it. While I was standing with the vehicle, I observed a black AR15 rifle laying on the back floorboard of the vehicle. The rifle was in plain view and immediately accessible by the defendant. A criminal history check confirmed the defendant was a convicted felon.

A probable cause search of the vehicle was conducted and I located a small blue plastic cylinder inside the passenger compartment inside the center the console. Inside the cylinder I located a plastic bag which contained a white crystalline substance. This substance was field tested presumptive positive for methamphetamine.

Located in the rear passenger compartment of the SUV, leaning against the back of the center console, Sergeant Hehl located a black AR15 rifle with approximately 52 rounds of ammunition and a makeshift "triple mag" inserted in the weapon.

Based on my investigation, which consisted of physical evidence found both on the defendants person and inside the vehicle he was operating, I believe the defendant, Joshua David Lawrence, willfully and deliberately violated the above statutes.
