[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 5/20/2019, the defendant, Niriah Lavon Rudolph committed the offenses of Kidnapping and Robbery with a Firearm based on the following:

On the above date and time, the co-defendant, identified as Celeste D'Ann Templin arranged the purchase of illegal narcotics in the form of two marijuana cartridges for \$150 via the social media site, Snap Chat. The arrangements

made by the co-defendant were she would meet the victim at his residence, 110 Oakhill Avenue to complete the transaction. The defendant accompanied the co-defendant as she drove her vehicle to the victim's address. Upon arrival at the victim's residence, the victim entered the co-defendant's vehicle where the defendant pointed his gun at the victim. A struggle ensued and the co-defendant drove her vehicle away, with the victim still inside as he continued struggling with the defendant. The co-defendant made several turns while continuing to drive away from the victim's residence. The victim was eventually able to free himself and exit the vehicle.

In a post-Miranda interview with the co-defendant, she confessed to arranging the purchase of the illegal narcotics and traveling to the predetermined location with the knowledge neither she, nor the defendant had the money to complete the purchase. The co-defendant confessed she arrived at the victim's residence with the intent to rob the victim of the illegal narcotics. The defendant confessed to driving her vehicle away, knowing the victim was still inside struggling with the co-defendant. The co-defendant identified the defendant as "Fred Rudolph". A check of the defendant's Department of Juvenile Justice Youth Information sheet showed "Fred" is listed as one of the defendant's alias.

During an interview with the victim, he wrote the "Nyriah Rudolph" on a piece of paper as the person in the rear seat of the co-defendant's vehicle that was armed and robbed him.

Based on the above-mentioned facts and circumstances, I have probable cause to believe the defendant committed the offenses of Kidnapping and Robbery with a Firearm. This offense occurred in Okaloosa County, Florida and violates F.S.S. 787.01 (1)(a)(1) and 812.13 (2)(a).

The arrangements made by the defendant were she would meet the victim at his residence, 110 Oakhill Avenue to complete the transaction. The defendant drove her vehicle with another individual to the victim's address. Upon arrival to the victim's residence, the victim entered the defendant's vehicle where he was robbed at gumpoint by the co-defendant. A struggle ensued and the defendant drove her vehicle away, with the victim still inside as he continued struggling with the co-defendant. The defendant made several turns while continuing to drive away from the victim's residence. The victim was eventually able to free himself and exit the vehicle.

In a post-Miranda interview, the defendant confessed to arranging the purchase of the illegal narcotics. The defendant further confessed she arranged this purchase with the knowledge she did not have the money to complete the purchase. The defendant confessed she arrived at the victim's residence with the intent to rob the victim of the illegal narcotics. The defendant confessed to driving her vehicle away, knowing the victim was still inside struggling with the co-defendant.

Based on the above-mentioned facts and circumstances, I have probable cause to believe the defendant committed the offenses of Kidnapping and Robbery with a Firearm. This offense occurred in Okaloosa County, Florida and violates F.S.S. 787.01 (1)(a)(1) and 812.13 (2)(a).
