A narcotic transaction was arranged by co-defendant Burns to co-defendant Craig Rudolph for the purchase of a half pound of marijuana for the amount of \$550.00. Upon the arrival of the co-defendants Rudolph, Shatavia Foreman and Brenden Scarver, gunshots began from inside the residence towards the vehicle and from the vehicle to the residence. One of the gunshots fatally struck the victim, Cordell Keaton Smart who was standing in front of the residence.

The defendant contacted co-defendant Daniel Heath and advised him of a Robbery that occurred earlier in the day where co-defendant Monfils was the victim. An agreement was made between the defendant and co-defendant to come to the defendant's address in the event of retaliation. Co-defendant Heath traveled to his house where he retrieved three firearms, including a .380 caliber handgun and 9mm carbine rifle. Co-defendant Heath brought the firearms to the defendant's residence (110 Oakhill Avenue). A narcotic transaction was arranged by the defendant to co-defendant Craig Rudolph for the purchase of a half pound of marijuana for the amount of \$550.00. Upon the arrival of the co-defendants Rudolph, Shatavia Foreman and Brenden Scarver, gunshots began from inside the residence towards the vehicle and from the vehicle to the residence. One of the gunshots fatally struck the victim, Cordell Keaton Smart who was standing in front of the residence.

In a post-Miranda interview, the defendant confessed he contacted co-defendant Heath and advised him of the earlier Robbery. The defendant further confessed to arranging the sale of a half of a pound of Marijuana to co-defendant Rudolph. The defendant confessed once co-defendant Heath arrived at his residence with the firearms, he armed himself with a .380 LCP handgun and fired it outside the residence. Based on the testimony of co-defendant Heath, this shot was fired in the direction of the vehicle containing co-defendants Foreman, Scarver and Rudolph. A single 380 caliber shell casing was located inside the doorway of the defendant's residence where he confessed to firing the shot from.

On 5/20/2019, the defendant, Shatavia Foreman committed the offense of Murder in the Third Degree based on the following:

The defendant drove her vehicle to 110 Oakhill Avenue with co-defendants Craig Rudolph and Brenden Scarver to complete a pre-arranged purchase of marijuana. This arrangement was made between co-defendants Rudolph and Sterlin Burns. A short time after the defendant's arrival at 110 Oakhill Avenue, gunshots were fired from within the residence. Return gunfire began from within the defendant's vehicle. One of the gunshots from the co-defendants fatally struck the victim, Cordell Keaton Smart who was standing in front of the residence.

In a post-Miranda interview, the defendant confessed to driving to the pre-arranged location (110 Oakhill Avenue) so co-defendant Rudolph could complete the purchase of marijuana from co-defendants Gaige Monfils and Sterlin Burns. The defendant further confessed co-defendant Scarver fired two gunshots from within the vehicle in the direction of the residence.

On 5/20/2019 The defendant's vehicle was located and she was seated in the driver's seat and co-defendant Scarver was in the passenger seat. When co-defendant Scarver exited the vehicle, a loaded handgun was found directly beneath him. A search of the defendant's vehicle, pursuant to a search warrant resulted in locating gunpowder residue within the interior of the vehicle.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 5/20/2019, the defendant, Daniel Jacktoo Heath committed the offense of Murder in the Third Degree based on the following:

The defendant was contacted by co-defendants Gaige Monfils and Sterlin Burns and advised of a Robbery where co-defendant Monfils was the victim. At the request of co-defendant Monfils, the defendant traveled to his house where he retrieved three firearms (.380 caliber, .45 caliber and 9mm carbine rifle) and brought them to co-defendant's Monfils and Burns' residence (110 Oakhill Avenue). A narcotic transaction was facilitated by co-defendant Burns to co-defendant Craig Rudolph for the purchase of a half pound of marijuana for the amount of \$550.00. Upon the arrival of the co-defendants Rudolph, Shatavia Foreman and Brenden Scarver, gunshots began from inside the residence towards the vehicle and from the vehicle to the residence. One of the gunshots fatally struck the victim, Cordell Keaton Smart who was standing in front of the residence.

In a post-Miranda interview, the defendant confessed to traveling to his residence with co-defendant Monfils and Keanau Askew to retrieve the three firearms. The defendant further confessed to bringing the firearms, along with masks to conceal their identity and gloves to 110 Oakhill Avenue. While arming himself with the 9mm carbine rifle, the defendant confessed to wearing one of the masks while other co-defendants concealed their identity and possessed the other firearms. The defendant stated when the vehicle containing co-defendants Foreman, Scarver and Rudolph arrived, a single gunshot was fired from inside the residence, at which time gunshots were fired from inside the vehicle. The defendant confessed to firing a shot from his rifle in at an individual coming in his direction with a gun. In the area the defendant stated he fired the shot from, a 9mm shell casing was located.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 5/20/2019, the defendant, Brendon De Shawn Scarver committed the offense of Murder in the Third Degree based on the following:

The defendant was a passenger in a vehicle driven by co-defendant Shatavia Foreman. Co-defendant Foreman drove her vehicle to 110 Oakhill Avenue with another co-defendant, Craig Rudolph to complete a pre-arranged purchase of marijuana. Based on sworn witness testimony, this arrangement was made between the defendant and co-defendant Sterlin Burns. A short time after the defendant's arrival at 110 Oakhill Avenue, gunshots were fired from within the residence. Return gunfire began from within the defendant's vehicle. During the exchange of gunfire, the victim Cordell Keaton Smart was shot and killed.

In a post-Miranda interview with co-defendant Foreman, she confessed to driving to the pre-arranged location (110 Oakhill Avenue) so co-defendant Rudolph could complete the purchase of marijuana from co-defendants Gaige Monfils and Sterlin Burns. The co-defendant further confessed co-defendant Scarver fired two gunshots from within the vehicle in the direction of the residence.

In a post-Miranda interview with the defendant, he confessed to knowing he was traveling to 110 Oakhill Avenue for the purchase of marijuana. The defendant further confessed the handgun that was found under the seat he was sitting in co-defendant Foreman's vehicle was his.

REPORT NO: OCSO19ARR005725

On 5/20/2019, co-defendant Foreman's vehicle was located and was searched pursuant to a search warrant which resulted in locating The handgun, belonging to the defendant, as well as gumpowder residue within the interior of the vehicle. This is indicative of a gunshot coming from within the vehicle.

Based on the above-mentioned facts and totality of the circumstances, the defendant was engaged in the perpetration of or the attempt to perpetrate another felony (to wit: Sale of Illegal Narcotics) which resulted in the unlawful killing of a human being.
