[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

#### OKALOOSA CO SHERIFF'S OFFICE

On May 30, 2019, at approximately 0530 hours, the victim, //////////(19 yoa), contacted the Okaloosa County Sheriff's Office dispatch reporting she was battered by defendant, Blaise Albertie-Chamberlain (28 yoa), in the area of 746 Harbor Blvd, Destin, FL. The defendant and the victim reside as a family in the same residence (Okaloosa County) and have been in a relationship for approximately 3 weeks. The victim was transported to the Fort Walton Beach Medical Center (FWBMC) to treat her injuries. At approximately 0731 hours, I made contact with the victim and she advised the defendant intentionally struck her face multiple times with a closed fist inside of his vehicle. The defendant strangled the victim by her neck restricting her airway (unable to breathe). The defendant possessed a firearm (handgun) and struck the victims face multiple times with the firearm. The defendant threatened to kill the victim while holding the firearm to her head, which caused to her to be in fear for her life. When the victim attempted to exit the vehicle the defendant pulled her back into the vehicle by her hair, against her will. Eventually, the victim was able to escape by jumping out of the vehicle causing road rash to her knees and right foot. The victim sustained multiple injuries to her face caused by the defendant; small laceration (forehead), laceration (both lips), bruising and swelling to both eyes, bruising and swelling to victims jaw/cheeks. The victim was sworn to her verbal statement. At approximately 0840 hours, witness, //////per sworn statement advised she witnessed the physical altercation between the parties. She initially heard yelling coming from the defendant's vehicle. She observed the victim's legs in the air as if the defendant had the victim in a "choke hold" because her head was not visible. Shortly after, the parties entered their residence and she observed the injuries to the victims face (swelling). The defendant then threatened to kill the victim, witness, and ///////////////////// who was also inside the residence. The defendant fled the scene and was later located at FWBMC. A criminal history for the defendant revealed a prior conviction for Battery by Strangulation (DOMV) on 3/24/14 (Okaloosa County Sheriff's Office). Based on the above stated facts, I have reason to believe and do believe the defendant, Blaise Albertie-Chamberlain, intentionally struck the victim multiple times with a closed fist and with a weapon (firearm). The defendant also restrained the victim from exiting his vehicle and strangled her by restricting her airway against her will, which is a violation of Florida State Statutes, F.S.S 784.03(2) Battery w/great bodily harm (2nd Subsq), F.S.S 784.041 (2a) Battery by Strangulation (DOMV), F.S.S 784.045 (1a2) Aggravated Battery w/deadly weapon, and F.S.S 787.02(1a) False Imprisonment. This offense occurred in Okaloosa County where I am a sworn Criminal Investigator with the Office of the Sheriff.
