**[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]**

The defendant, Dennis Toomer, did commit the offenses of Criminal Mischief pursuant to Florida State Statute 806.13(1b3), Child Abuse pursuant to Florida State Statute 827.03(2c), Aggravated Battery pursuant to Florida State Statute 784.045(1b), Resisting Officer w/o Violence pursuant to Florida State Statute 843.02, Possession of a Firearm by a Convicted Felon pursuant to Florida State Statute 790.23(1a), Possession of a Firearm during the Commission of a Felony pursuant to Florida State Statute 790.07(2), Tampering with Evidence pursuant to Florida State Statute 918.13(1a), and Felony Probation Violation pursuant to Florida State Statute 948.06(a).

On May 8, 2019 the defendant got into an argument with, Briana White (victim 1), whom is 6 months pregnant and obviously showing at her home located at 1707 Colonial Ct. White and the defendant have been in a continuous, intimate, dating relationship since January 2019. The [REDACTED] heard the two arguing and came out of their room and witnessed the defendant hitting White in the face. [REDACTED] pulled White into their bedroom and locked the door. The defendant forced the door open causing approximately \$1,500 in damage to the frame and started to strike White again. [REDACTED] grabbed a glass bottle and hit the defendant in the head

with it in an effort to protect [REDACTED] This caused the defendant to then attack [REDACTED] who is a juvenile, and strike him in the chest. The defendant told all three parties that he had a gun and was going to use it. He pulled the gun from his right hip and held it in his hand showing it to them. They all described the firearm in the same way, a black and gray 9mm handgun.

When deputies arrived on scene, the defendant refused our lawful commands to show us his hands and come downstairs. Commands were given in excess of ten minutes. When the defendant was eventually taken into custody, no firearm was located around or on his person. Consent to search the home for the firearm was given by White. A firearm fitting the description given was located outside of the room the defendant was in. It was inside of a box concealed underneath two packages of tile.

A query of the defendant's criminal history revealed that he is a convicted felon as of October 15, 2015. It was also discovered that he is on felony probation with an entry date of April 9, 2019 and a release date of April 16, 2020.

These offenses occurred in Okaloosa County, FL where I am a full-time law enforcement officer.
