[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 11, 2019, the Polk County Sheriff's Office responded to [REDACTED] Winter Haven, Florida 33881, in reference to a lewd act. Upon the responding deputy's arrival she met with [REDACTED] the mother of 9-year-old [REDACTED] [REDACTED] stated to the deputy that on June 9, 2019 she became aware that her daughter was in contact with an unknown adult male.

On June 11, 2019, the deputy interviewed [REDACTED]. During the interview [REDACTED] stated she was playing an online game called "The Wolf". The game The Wolf is a Role Playing Game (RPG) where the player is a member of a wolf pack. In the game the player develops his/her character with the assistance of other players. The game allows individuals the ability to create a team, play together and communicate through friend's lists and chat options. The game can be played on multiple platforms to include iOS and Android operating systems. [REDACTED] stated while playing the game she met another player who stated their name was Jade and was an 11-year-old female. The conversation between [REDACTED] and Jade moved from the game to the TextNow application with Jade using the phone number [REDACTED]. During this conversation [REDACTED] and Jade engaged in a sexual conversation in which both [REDACTED] and Jade talked about having sex, performing oral sex and having a threesome. Also during this conversation Jade asked [REDACTED] she wanted to have a sexual encounter with a friend named Jason who was 31-years-old. [REDACTED] then began conversing with the adult male identified as Jason. The adult male's phone number was identified as [REDACTED]. During these conversations the adult male identified as Jason solicited [REDACTED] for a sexual encounter and sent [REDACTED] a picture of a penis. During the interview [REDACTED] also admitted she had given her address to the adult male identified as Jason.

The deputy then manually reviewed [redacted] cell phone, described as a LG Model LM-XZ10MA with serial number [redacted]. The deputy noted in her report she observed text messages between [redacted] and Jade beginning on June 8, 2019 that were sexual in nature where [redacted] and Jade spoke about specific sexual acts. The deputy also noted she observed [redacted] and Jade exchanged images. The deputy did not note the nature of the images exchanged. The deputy also noted in her report that she observed text messages between [redacted] and the adult male identified as Jason which were sexual in nature and that [redacted] and Jason agreed to meet for a sexual encounter which included Jade. The deputy also noted she observed images sent from the adult male identified as Jason and that some on the images were penis pictures.

During the investigation the Polk County Sheriff's Office identified that the adult male's telephone number of [redacted] was in the control of Pinger, Inc.

On June 13, 2019, Detective Christy Smith with the Polk County Sheriff's Office submitted an exigent request to Pinger, Inc. for the phone number [redacted]

On June 13, 2019, [redacted] responded that the phone number [redacted] was associated with the Textfree application. The additional following information was associated with the account:

- Last Known Internet Protocol (IP) Address: [redacted] with the capture date and time of June 9, 2019 at 17:17:54 UTC.
- Email Address Associated with the Account: [redacted]

Following receipt of the information from Pinger, Inc. Detective Christy Smith with the Polk County Sheriff's Office submitted an exigent request to Cox Communication, who is the controlling company for the IP address [redacted]

On June 13, 2019, Cox Communication responded to the exigent request for IP address [redacted]. Per the subpoena return the IP address [redacted] was leased to, Boots Sadler of [redacted]

On June 17, 2019, your Affiant reviewed the text messages which occurred between the suspect posing as the juvenile Jade and the juvenile victim. In the conversations the suspect enticed the juvenile victim by asking her if she wanted to have sex with Jason (who is portrayed by the same person as Jade) and if either she, the juvenile victim or Jade is going to have sex first. The suspect also posing as Jade asked the juvenile victim if she was going to kiss her or Jason first and if Jason need to use a condom when he had sex with the juvenile victim.

On June 17, 2019 your Affiant reviewed the text messages between the suspect posing as Jason and the juvenile victim. In the conversations the suspect solicited the juvenile victim by asking "Do you want me to fuck you?" and then followed that comment up with "U cant' tell anyone". The suspect later solicited the juvenile female by asking "You want to suck my dick or want me to fuck You"

In both instance in which your Affiant reviewed are violations of Florida State Statute 847.

Your Affiant knows that the Textfree application (formerly Pinger) is an application made by Pinger Inc. that allows users to text and call over the internet for free or for a price. The application runs on iOS, Android, Microsoft Windows and Macintosh devices. Your Affiant knows from training and experience the when the Textfree application is downloaded to an electronic device that the application assigns a phone number to the account. This phone number is unique to the account and in a case where the application is downloaded to a phone the phone number is different than the phone number which in assigned by a phone carrier.

On June 19, 2019, Cansas Sadler Jr. was interviewed at the Okaloosa County Sheriff's Office. Post Miranda, Sadler admitted the email address [redacted] was his email address. Sadler also admitted that he played the mobile game The Wolf. When Sadler was shown facial pictures which were sent to the juvenile, Sadler admitted the adult male in the pictures was his friend but stated he did not know the juvenile females pictured. Sadler also stated the pictured friend has never been to his current residence. Sadler denied all allegations and stated his email address had

been hacked and that he never used the applications TextNow and Textfree.

A search warrant was signed and executed on Sadler's phone. In review of the forensic download of Sadler's phone it was able to be determined that both the TextNow and Textfree applications were downloaded on the phone and there is additional evidence on the phone which shows that both applications were accessed and used during the time frame the text messages occurred. This would indicate that Sadler was posing as the original juvenile female, Jade, and the adult, Jason, who was conversing with the juvenile victim. Also discovered on the phone was a web search history containing a specific search term. When this search term was repeated by an investigator, two penis images (which appeared to be the same as those sent to the juvenile female) were discovered.

Interviews were conducted with family members who reside in the residence and have access to the internet and all of them denied using the TextNow and Textfree applications.

Based on the aforementioned information I have reason to believe and do believe Cansas Sadler Jr. did violate Florida State Statutes 847.0135 (3a) Use of a Computer to Seduce/Solicit/Entice a minor; 847.0135 (3a) Use of a Computer to Seduce/Solicit/Entice a minor with the enhancement of the misrepresentation of age (posing as 11-year-old Jade) and 934.215 Use of a two way communication device to commit a felony. This incident occurred in Okaloosa County, Florida where your Affiant is a sworn law enforcement officer.
